# Northern Australia Food Futures Conference 2018

#### **Terms & Conditions:**

Please read the below terms and conditions carefully. By selecting 'Yes' and proceeding with your booking you are agreeing to the terms and conditions as listed below.

#### 1. Registration:

- 1.1. Bookings are confirmed only when full payment is received in cleared funds. Once your booking is confirmed it is your responsibility to update any changes to your booking by logging on to your booking using your username and password. If you have any special requests, you should also bring these to the attention of the conference organiser.
- 1.2. No refunds on conference bookings will be issued within 35 days of the conference commencing. Cancellations must be notified in writing via email to the Conference Coordinators. Cancellations received up to 30 days prior to the event commencement date (2 July 2018) will receive a refund less a handling fee of \$33 including GST. No refund will be given after this date; however a substitute delegate name may be submitted.
- 1.3. It is the delegates, speakers, sponsors and exhibitors responsibility to ensure that details regarding special dietary requirements are made known to the conference coordinator at the time of booking.

### 2. Conference materials:

- 2.1. Images/Photos: In registering for this conference, delegates, speakers, sponsors and exhibitors grant permission to Northern Territory Farmers Association (NTFA), its agents and others working under its authority, to take and to have full and free use of video/photographs containing their image/likeness. - 2.2. Speakers' presentations: All speakers and panellists agree that all materials presented at the Conference may be available afterwards online at the Conference website.
- 2.3. Conference app: The delegate agrees to share basic contact information with delegates, sponsors and conference stakeholders through the conference application.

# 3. Behaviour:

NTFA reserves the right to prohibit entry to any person to an NTFA event, or eject any person from an NTFA event based on behaviour deemed inappropriate by NTFA staff and/or its agents and others working under its authority. Promotional materials may not be distributed at the event except by event sponsors and exhibitors. Delegates, speakers, sponsors or exhibitors violating this policy will be asked to leave the event and NTFA members may have their membership revoked.

## 4. Program:

NTFA reserves the right to make changes to the program at any time as circumstances dictate. Every effort will be made to ensure a program of equivalent standard and value should unavoidable changes occur. Registration places are limited and will be allocated on a strictly 'first in' payment basis. In the event that space is unavailable you will be promptly notified.

#### 5. Discount for NTFA Members:

NTFA members are entitled to discount registration in line with their membership level. NTFA member registration rates are not transferable to non-NTFA members. By selecting a member registration rate, it is agreed that the registrant is a current financial member of NTFA and that the registration is made in the NTFA member's name only. Any breach of this may result in a cancellation of the conference registration and/or NTFA membership.

### 6. List of participants:

In registering for this conference, relevant details may be incorporated into a delegate list for the benefit of all delegates (name, organisation and state). Further details may be available to parties directly related

to the conference including the conference registration managers, NTFA, venues and accommodation providers (for the purpose of room bookings, special catering and physical requirements, name tag creation and conference options). Sponsors will be supplied with the full name, title, organisation, state and email addresses of those delegates who do not 'opt out'.
