ITEM 1

These Cancellation Terms relate specifically to the Amaco South Africa Golf Journey 2027 travelling 25 July to 6 August 2027. Any third-party travel arrangements that may have been booked in conjunction with the journey will be governed by the terms and conditions of the operator supplying those services and should be read in conjunction with the terms below. If you cancel your booking:

- a on or before Friday, 12 February 2027, you will forfeit the Travel Package Deposit (Total B). Additionally, third-party charges may be applied by hotels, airlines, golf courses, ground operators and other suppliers if additional travel arrangements have been made.
- b on or after Saturday, 13 February 2027 and on or before Friday, 23 April 2027, you will be liable for 50% of the value of the Amaco South Africa Golf Journey 2027 Travel Package booked, including any single supplement or other package upgrades (Total A), if applicable. Additionally, third-party charges may be applied by hotels, airlines, golf courses, ground operators and other suppliers if additional travel arrangements have been made.
- c on or after Saturday, 24 April 2027, you will be liable for the full value of the Amaco South Africa Golf Journey 2027 Travel Package booked, including any single supplement or other package upgrades (Total A), if applicable. Additionally, third-party charges may be applied by hotels, airlines, golf

courses, ground operators and other suppliers if additional travel arrangements have been made.

Unused portions of the Travel Package will not be refunded. Any additional or extension travel bookings made in conjunction with the Amaco South Africa Golf Journey 2027 will be governed by the terms and conditions applicable to the operator supplying those services.

ITEM 2

The balance of your Travel Package will be due on or before Friday, 23 April 2027, being approximately 90 days prior to commencement of the journey. You will be invoiced accordingly. Amaco reserves the right to charge a late fee on any payments received after this date.

If registering on or after Saturday, 24 April 2027, the full amount of the Travel Package (Total A), including any single supplement or other package upgrades, will be due immediately.

PERSONAL SAFETY

Travellers are responsible for considering relevant government travel advice and their individual circumstances when deciding whether to travel. By completing the Registration Form, you acknowledge that your decision to participate in the Amaco South Africa Golf Journey 2027 is made after due consideration of relevant travel information.

1. MEANINGS OF WORDS

- 1.1 In this Agreement, unless the context requires otherwise:
Agreement means these Booking Terms & Conditions, the attached Schedules and the Booking Documents;
Booking Documents means the registration form, itinerary, brochure, invoice and other documents issued by Us relating to Your booking;
Travel Package means the Amaco South Africa Golf Journey 2027 travel, accommodation, golf and touring arrangements described in the Booking Documents;
Travel Supplier means any independent third party providing travel or other services forming part of, or booked in connection with, the Travel Package, including airlines, hotels, golf courses, ground operators, transport providers and attractions;
We, Us and Our means Amaco SGT Pty Ltd of Suite 23, 27 – 31 Duerdin Street, Notting Hill, Victoria 3168; and
You and Your means the person/s registering to participate in the Travel Package and described in Schedule 1.

2. AGREEMENT

- 2.1 These Terms & Conditions and the Schedules together constitute the Agreement between You and Us in relation to Your booking.
2.2 By signing or otherwise accepting the declaration forming part of this Agreement, You agree to be bound by these Terms & Conditions.
2.3 Amaco arranges components of the Travel Package using independent Travel Suppliers. We are responsible for providing Our travel planning, booking, administration and related services with due care and skill and in accordance with applicable Australian law.
2.4 Travel Suppliers are responsible for the day-to-day operation and provision of the services they supply and may impose their own booking and operating conditions.

3. PRICING

- 3.1 All quoted prices are in Australian dollars and are based on the costs, taxes, charges and exchange rates applicable when the Travel Package is priced.
3.2 Once Your booking has been confirmed, We will not increase the Travel Package price simply because We wish to charge more. However, You remain responsible for additional amounts legitimately imposed after booking by a Travel Supplier, government or relevant authority, or arising from material changes to taxes, statutory charges or other components outside Our reasonable control, where permitted by applicable law.
3.3 If a material price increase becomes necessary before travel, We will advise You of the reason and any reasonably available options.
3.4 Any additional flights, accommodation, stopovers, upgrades or other arrangements requested by You that are not included in the Travel Package will be at Your expense.

4. CANCELLATIONS

- 4.1 If Your booking has been confirmed and You cancel, cancellation fees will apply in accordance with Item 1 of Schedule 2.
4.2 Additional travel arrangements made outside the Travel Package may be subject to separate Travel Supplier cancellation charges, which will be advised where applicable.
4.3 If We are required to cancel the Travel Package because minimum participation requirements have not been achieved, We will notify You as soon as reasonably practicable and refund amounts paid by You to Us for the cancelled Travel Package.
4.4 If We are required to cancel or materially change the Travel Package for other reasons, Your rights and any refund, credit or alternative arrangements available will depend upon the circumstances, applicable Travel Supplier terms and Australian Consumer Law.
4.5 No refund will be made for portions of the Travel Package voluntarily unused by You after commencement of the journey.

5. PAYMENTS

- 5.1 All payments must be made to Us in Australian dollars in accordance with Item 2 of Schedule 2.
5.2 Deposits and final payments must be received by the dates specified. Failure to make payment when due may result in cancellation of Your booking and applicable cancellation charges.
5.3 Payment is treated as received when cleared funds are available to Us.

6. TRAVEL INSURANCE

- 6.1 We strongly recommend that You obtain comprehensive travel insurance at the time You make Your booking.
6.2 Appropriate insurance should, having regard to Your individual circumstances, include cover for cancellation and curtailment, overseas medical expenses, emergency evacuation, personal belongings and, for golfers, golf equipment.
6.3 Whilst We may assist You with information concerning travel insurance, You are responsible for ensuring that any policy selected is appropriate for Your individual circumstances and the Travel Package.

7. TRAVEL DOCUMENTS, HEALTH, SAFETY AND PARTICIPATION

- 7.1 **Passports and Visas**
You are responsible for ensuring that You hold a valid passport, visas and other documentation required for all countries visited or transited. The name provided to Us must match Your passport. You are responsible for costs resulting from incorrect information or inadequate travel documentation.
7.2 **Health, Fitness and Mobility**
You are responsible for considering whether You are reasonably able to participate in Your selected programme and for advising Us of any mobility, assistance or other requirements that may materially affect Your participation.

You are responsible for obtaining appropriate advice regarding health, medication, vaccination and other requirements applicable to Your travel.

7.3 Safety

You are responsible for considering relevant government travel advice when deciding whether to travel. We recommend consulting the Australian Government's Smarttraveller advice for current destination information.

8. CONDUCT

- 8.1 You must behave in a manner that does not unreasonably interfere with the safety, comfort or enjoyment of other participants, Amaco representatives, Travel Suppliers or members of the public.
8.2 You must comply with applicable laws, reasonable instructions provided by Us or Our Travel Suppliers, and be present at the required time for transfers, activities, flights and other arrangements.
8.3 In cases of serious or repeated misconduct, We may, after reasonable warning where appropriate, require You to leave the Travel Package. Any additional travel or other costs resulting from Your removal will be Your responsibility.

9. GOLF PROGRAMME

- 9.1 Golf courses, tee times and playing arrangements are subject to availability, weather, course conditions and operational requirements.
9.2 Golfers must comply with the rules, dress requirements, handicap requirements and reasonable directions of each golf course and must provide accurate handicap information when requested.
9.3 If a scheduled golf course or round becomes unavailable, We will, where reasonably practicable, endeavour to provide a suitable alternative. Any refund, credit or alternative arrangement will depend upon the circumstances and amounts recoverable from the relevant Travel Supplier.

10. ITINERARY CHANGES

- 10.1 We may make reasonable changes to the itinerary where necessary because of weather, operational requirements, supplier changes, safety considerations or circumstances outside Our reasonable control.
10.2 Where reasonably practicable, We will endeavour to provide an alternative service, activity, accommodation or experience of a similar standard.
10.3 If a material change is required before or during travel, We will advise You as soon as reasonably practicable and explain any reasonably available alternatives.

11. TRAVEL SUPPLIERS AND LIABILITY

- 11.1 Components of the Travel Package are provided by independent Travel Suppliers. We do not control their day-to-day operations, aircraft, vehicles, accommodation, golf courses, attractions or other services.
11.2 We are responsible for providing Our services with due care and

skill. We are not responsible for acts, omissions, delays or failures of independent Travel Suppliers or circumstances outside Our reasonable control except to the extent that responsibility cannot lawfully be excluded.

- 11.3 Nothing in this Agreement excludes, restricts or modifies any consumer guarantee, right or remedy that cannot lawfully be excluded under the Australian Consumer Law or other applicable law.

12. ADDITIONAL TRAVEL ARRANGEMENTS

- 12.1 If You choose to extend Your stay or make additional travel arrangements, We may assist You subject to availability and applicable pricing.
12.2 Additional arrangements not included in the Travel Package may be subject to separate Travel Supplier terms, payment requirements and cancellation conditions.
12.3 Any changes requested by You to Your confirmed travel arrangements may result in additional costs, which will be Your responsibility.

13. PRIVACY

- 13.1 We collect, use and retain personal information reasonably necessary to arrange and deliver Your Travel Package and related services.
13.2 You authorise Us to disclose information reasonably required by Travel Suppliers, including airlines, hotels, golf courses, ground operators and other service providers, for the purpose of arranging and providing Your travel services.
13.3 Personal information will be handled in accordance with applicable Australian privacy law and Our Privacy Policy.

14. GENERAL

- 14.1 This Agreement constitutes the agreement between Us and You concerning the Travel Package together with the Booking Documents.
14.2 If any provision of this Agreement is found to be void, illegal or unenforceable, that provision will be severed and the remaining provisions will continue to operate.
14.3 This Agreement is governed by the laws of Victoria, Australia and the parties submit to the jurisdiction of the courts of Victoria.
14.4 Nothing in this Agreement limits any rights or remedies available to You that cannot lawfully be excluded or limited.

15. DECLARATION

I/We have read and understand the information contained in this Agreement, including Schedule 1 and Schedule 2. I/We agree to be bound by these Booking Terms & Conditions and wish to book the participant/s named in Schedule 1 on the Amaco South Africa Golf Journey 2027.
