

INFORMATION CONSENT AND RELEASE FORM

I irrevocably authorise and consent to the following:

- LifeHealthcare Distribution Pty Limited (ABN 30 117 449 6. 911) an EBOS Medical Technology Division Company and its related companies (collectively, EMT), may record my image, voice, biographical material or other information about me on photographic images, video footage, digital images, audio recordings, spoken and written words of me, (or extracts of the same) and any other details collected as agreed between EMT and myself (or any combination thereof) concerning the Event (Information);

EMT has the right to use the Information and that I will not retain any rights, nor receive or make a claim, compensation or remuneration including copyright, or interest in the Information or such use by EMT, and I will not receive and make no claim for payment, royalties or fees against EMT in relation to the use of my Information.
- Release, defend, hold harmless and indemnify EMT, including any firm publishing and/or distributing the finished product in whole or in part, whether on paper, via electronic media, or on Websites, from any loss, damage, cost, expense, claim or liability for libel, slander, breach of privacy, copyright of trademark violation, right of publicity, arising out of or related to the use or release of my Information by EMT created and used in accordance with this consent and release, including but not limited to any misuse, distortion, blurring, alteration, optical illusion, or use in the composite form, either processing, reduction, or production of the finished product, its publication, or distribution.

I acknowledge that I am not required to provide the Information to EMT and that I am entering into this consent and release knowingly, freely and voluntarily. I understand that I am free to address any specific questions regarding this consent and release by submitting those questions in writing prior to signing, and I agree that my failure to do so will be interpreted as a free and knowledgeable acceptance of the terms of this consent and release.
