### Abstract Guidelines: Oral Presentations and Posters

#### Abstract Submission Deadline: 27 October 2024

These abstract guidelines must be followed for your presentation to be considered. Please ensure that the presenting author completes the abstract submission. Abstracts must be submitted by the deadline: **11.59pm, Sunday 27 October, Australian Eastern Standard Time.**

Authors will be informed of the acceptance of their abstracts by email after scientific review.

- Submitted abstracts will be evaluated on scientific merit and originality by the International Scientific Committee.
- Abstracts must be written in English, and, if accepted, the presentations must be in English.
- The total number of abstracts allowed to be submitted by the same author is 3.

The WAS Scientific Committee will decide on the final format (poster or oral/symposium) of the presentation. Accepted abstracts will be assigned for oral or (moderated) poster presentation by the WAS Scientific Committee. High quality abstracts in select categories may be chosen for presentation during a symposium session.

CONFLICT OF INTEREST AND DISCLOSURE STATEMENT: Any potential conflict of interest must be disclosed.

#### ABSTRACT SUBMISSION PROCESS

Abstracts must be submitted electronically through the online abstract submission site. You will be required to enter:

- Abstract title
- Preferred track
- Keywords
- Preferred presentation type (oral presentation / poster presentation)
- Authors' names (indicate presenting author and contact details - address, telephone and email). Note: Abstract presenters will be required to fund their own attendance at the conference and should not submit an abstract if this is not possible. Scholarships are available and preference will be given to those who do submit abstracts, however authors should ensure they are able to fund their own travel if need be
- Authors' affiliations
- Abstract as a Word document (maximum 300 words) plus a disclosure of interest statement
- Short biography of the presenter (maximum 50 words). This information will be used by the session chair for introduction purposes and may be published in conference the literature

Disclaimer: The committee may allocate your presentation within an alternate theme while developing the best fit sessions.

#### CONFERENCE REGISTRATION

Abstract presenters are required to fund their own attendance at the conference and should not submit an abstract if this is not possible.

Notification of status will be advised in December 2024. All presenters must register for the conference before **28 February 2025 (early bird deadline)**. It will be assumed that any presenter not registered by this date has withdrawn from the program and their abstract will be removed from all sessions and documentation.
