
Sandra has worked tirelessly and persistently with NUAA staff to produce this evaluation.

NUAA Postal NSP

- NUAA has been posting equipment to people living in regional areas for at least ten years.
- Efforts to formally establish a postal NSP service were not approved until...
- COVID the pandemic allowed us to rapidly establish a postal NSP service






Today, the postal service accounts for >50% of our NSP Distribution

Postal THN

- Shortly after the establishment of postal NSP, a then NUAA Board member, Dr. Rob Page, facilitated a discussion with a local pharmacy participating in the Commonwealth naloxone program and the postal service started distributing naloxone on behalf of this pharmacy.
- This method of distribution was successful and further discussion with the NSW THN working group led to the NUAA postal service becoming part of the NSW NGO THN program. This program allows peers to train service users and distribute naloxone.

- High levels of confidence that they could respond to a suspected overdose.



Postal THN is reaching new people

- 60% had not previously done a THN intervention
- The pilot project had a high proportion of women (48%)
- High proportion of people (37%) from regional/remote locations accessed the service
- Relatively young cohort of service users
- 18% aged 26 30 years; 31% aged 31 40 years; 19% aged 41 50 years
- Most people accessing the service (94%) were very confident in using THN in the event of a suspected overdose
- Overall, 90% were 'very satisfied' and 7% 'somewhat satisfied' with the online service, and 98% indicated they would recommend the service a friend



Feedback

FROM OUR - AMAZING - SERVICE USERS

"I'd go to a pharmacy in the city and they would either look at me blankly, like I don't know what you're even referring to, or no, no, we don't have that here...happened maybe six times."

"I'm in a rural area and I am an ex-user....it's more convenient in a rural setting to have it posted out. It's much more accessible than going to a pharmacy....I don't think we have much of a face to face service that would provide that kind of thing where I live in this area."

"I wouldn't have felt comfortable going anywhere local....and it really is (NUAA) somewhere I trust."




Limitations/Issues

- Of the 295 people who initially registered for the course, only 95 completed. We have investigated this issue and developed a new infrastructure to better support learning of service users.
- Postals have been person dependent (thank you Alain our amazing NSP worker), we have now trained more staff members in the process.
- Work has been unfunded in the past, we now have some Ministry funding to deliver this service


