Equivalence of Healthcare (p.4)

The ACT has a community-based needle and syringe exchange in order to minimise the harm of disease transmission through intravenous drug use. Numerous studies have demonstrated the efficacy of these exchanges in communities around the world, as well as prisons in some countries.


To deny protection against disease transmission in such a high prevalence and closed population in prison may be viewed as inhumane. The Human Rights Commission recommends that a pilot program for a needle and syringe exchange should be developed, with adequate consultation, for the AMC.

ACT Corrections Management Act 2007

- 21 Doctors—health service appointments
- (1) The director-general responsible for the administration of the Public Health Act 1997 must appoint a doctor for each correctional centre.
- (2) (2) The doctor's functions are— (a) to provide health services to detainees; and (b) to protect the health of detainees (including preventing the spread of disease at correctional centres).

2009 - 2017

The testing programme for hepatitis C has indentified 107 infections in 95 people, since the AMC was commissioned.

- ▶ 22 are considered to be 'in-custody' transmissions
- ▶ 41 are considered 'indeterminate' as to environment of transmission (either custody or community), and
- ▶ 44 were determined as 'in-community' infections.
- ► Since March 2016 one in-custody infection

Prevalence of Hepatitis C Infection

2010 - prevalence of HCV Ab - 48% (presumed PCR positivity ~35%)

March (actually April) 2016 - DAA treatments commenced

October 2016 - 20% PCR positive

In just less than 18 months, PCR positivity reduced from ~30% to

So what about that Needle Exchange?

- ▶ Government commitment, supported by the Greens
- ► ACT Human Rights Commission support
- Australian Medical Association and Public Health Association support
- Mixed support from detainees
- Muted support from Non-Government Organizations
- Mixed messages from the Canberra Times
- Total opposition from prison officers, formalised through their Enterprise Bargaining Agreements, and subsequent vote
- ▶ Therapeutic prevention v harm minimisation
