Registration Terms and Conditions

Overview

Please read these Terms and Conditions carefully as they apply to your registration, attendance and participation at the ASIC Symposium 2026 (**Event**).

The venue for the Event is the **International Convention Centre Sydney (ICC) - 14 Darling Dr, Sydney NSW 2000**. The Event will be held on **Wednesday 4 March 2026**.

By registering, attending or speaking at the Event, you agree to be bound by the Terms and Conditions set out below, which form a legally binding agreement between you and the Australian Securities and Investments Commission, ABN 86 768 265 615 Event host (**ASIC**).

You agree to comply with any directions issued by ICC and ASIC staff during the event. This agreement will be provided upon request.

ASIC is the Event Organiser for the Event for the purposes of these Terms and Conditions.

The Event Organiser reserves the right to publish changes to these Terms and Conditions at any time without prior notice.

These Terms and Conditions are governed by the laws of the State of New South Wales, Australia. The courts of that State and of the Commonwealth of Australia have non-exclusive jurisdiction over any matters arising under these Terms and Conditions.

Registration platform

ASIC uses EventsAir, a third party event registration platform, to process and manage your registration for this event.

Please note that the EventsAir Terms of Service and Privacy Policy are third party provisions applicable only to registration and management of your registration. They do not apply to ASIC's organisation and conduct of the event.

Registration process

Register online via the ASIC Symposium web page asic.gov.au/events. All mandatory fields must be completed.

Only completed registration forms will be accepted. Registration is complete only when the specified fee is credited or received in full into our bank account.

If you choose to remain anonymous or use a pseudonym under privacy law or do not supply any requested information, in respect of the registration process for the Event, then your registration may be rejected as incomplete or invalid. The result of this is that you may not be able to attend the Event.

Before you click the 'Register" button, please read ASIC's Privacy Collection Notice for use of EventsAir. This policy applies to ASIC's collection and use of your personal information for purposes related to your registration to attend the event.

Registration fees

Individual tickets fees are \$330, inclusive of Goods and Services Tax (GST).

Payment methods

Full payment is required at the time of registration.

All attendees must pay by credit card. The accepted credit cards are MasterCard, Visa and American Express.

All credit card transactions will appear on your statement as 2026 ASIC Symposium.

The fees include credit card charges for our acceptance of credit card payment. You will be redirected to a secure payment site and issued with an invoice upon confirmation. Please retain your invoice number as a payment reference.

Cancellations

Any cancellation or refund request received by ASIC on and after Monday 23 February 2026 will attract a \$20 cancellation fee in accordance with these Terms and Conditions.

Non-attendance/no-shows

No refund will be made for non-attendance at the Event.

Change of the in-person event to a virtual-only event by ASIC

If ASIC determines, at its sole and absolute discretion, that the in-person Event cannot proceed due to unforeseen circumstances beyond its reasonable control (including but not limited to acts of God, natural disasters, pandemics, government restrictions, or any other emergencies), ASIC reserves the right to cancel, reschedule, or convert the Event to a virtual format. In such cases, ASIC will endeavor to notify all participants as soon as reasonably practicable. Any refund, credit, or alternative compensation will be provided at ASIC's sole discretion and in accordance with the refund policy.

Modification, cancellation, postponement or change of registration of the Event by ASIC

ASIC reserves the right to make changes to the Event's program, including presenters and sessions, where necessary.

In the unlikely event that a presenter withdraws, ASIC may at its absolute and sole discretion make appropriate decisions in response to this in the best interest of the Event. Please note that this will not include refunds but may include changes to the program and cancelling or re-arranging sessions.

It may be necessary, for reasons beyond the control of ASIC, to alter the times, dates, itineraries or speakers of the Event.

If the Event is cancelled or postponed by ASIC for any circumstances beyond the reasonable control of ASIC or for any other reasons, then ASIC's maximum liability is limited to a refund of the Event Registration Fees and ASIC has no additional liability for travel, hotel, or any other incidental costs or expenses whatsoever. For the purposes of this paragraph, "circumstances beyond the reasonable control of ASIC" include acts of terrorism, war or God, natural disaster, global health crisis, industrial action by a third party, or a government mandatory legal order or directions.

In the event of postponement of the Event, if the attendee is willing to attend the rescheduled event, we will transfer the registration and guarantee the same conditions and registration entitlements at the rescheduled event.

Religious, cultural and dietary requirements

Attendees should make their own enquiries if they require access to any religious or cultural facilities at the International Convention Centre Sydney.

The Event Organiser will make reasonable efforts to cater for dietary requirements identified in the attendees' registration process, but the Event Organiser does not guarantee all dietary requirements will be met and reserve its rights to offer reasonable alternative substitutes to any affected attendees.

Insurance

Registration fees do not include insurance of any kind. It is strongly recommended that attendees take out insurance at the time of registration to include any eventuality, including but not limited to:

- personal property, health and medical expenses, injury, death and any other risks associated with the attendee's registration and attendance at the Event;
- any costs or damages caused or contributed to by the attendee for ASIC and any other third parties in relation to the Event; and
- loss of fees through cancellation of any attendee's participation in the Event or through cancellation of the Event, loss of airfares through cancellation for any reason including airline or related services strikes, loss or damages to personal property, force majeure or any other reason.

Liability

Attendees agree that their attendance at the Event is at their own risk.

Attendees agree not to hold ASIC and its employees liable for any losses, damages, expenses, costs, claims or liabilities suffered or incurred by attendees including consequential or indirect losses or loss of profit through registering for the Event, attending the Event (whether in-person or virtually), cancellation or postponement of the Event, failure of the Event to achieve your expectations, or for any error or omission by ASIC.

For avoidance of doubt, ASIC is not liable or responsible for any information, data or material provided or contributed by you for the registration process, and attending and participating in the Event.

Attendees agree not to hold ASIC liable or responsible for any personal injury (i.e. physical, psychological or emotional stress) or any loss or damage to personal property.

ASIC Privacy Collection Notice – The ASIC Symposium

The Australian Securities and Investments Commission (**ASIC**) collects personal information using EventsAir for the purposes of managing and processing event registrations.

Information you provide to ASIC (**us/we/our**) in the event registration form will include personal information as defined under the *Privacy Act 1988 (Cth)* (the **Privacy Act**).

Purpose of collection	<p>We will collect, use, and disclose your information to:</p> <ul style="list-style-type: none">• record and manage your registration and attendance at the event for example to arrange payment, safety, security and accessibility for you at the event;• assist us in the administration of the event including collating a list of attendees to circulate (as necessary) to other attendees, presenters, and our event partners to deliver the event;• allow you to participate in activities of the event;• invite you to future stakeholder engagement events that we host; and• compile and analyse statistics and feedback about the event.
How we collect information	<p>We also collect it for the purposes of updating our ASIC Update mailing list which distributes emails about events and updates.</p> <p>We collect personal information from you or your authorised representative through the EventsAir registration management platform. EventsAir is an external event registration platform based in Australia.</p>
What information is collected?	<p>EventsAir will take what they believe to be reasonable steps to protect personal information collected from loss, misuse, unauthorised use, access, inadvertent disclosure, alteration and destruction. EventsAir will store your personal information in a password-protected account on Microsoft Azure servers based in Australia.</p> <p>Payment for event registration is securely processed through Stripe integrated with EventsAir, a third-party payment service provider.</p> <p>We will collect the following information about you:</p> <ul style="list-style-type: none">• full name;• contact details;• gender;• organisation and positions;

Consequences of not providing your personal information	If you do not consent to us collecting your information or provide the required personal details for registration, we may not be able to register you.
Disclosure to other bodies or persons	<p>We may disclose your personal information to other attendees (if you have elected for us to do so), presenters and third-party service providers for the event.</p> <p>We may also disclose your personal information where we are required or authorised by law, and where you have consented to the disclosure, or you would reasonably expect us to use or disclose the information for that purpose, and such purpose is related to the offer, provision and improvement of the event.</p> <p>Further information on the entities, bodies or persons, or the types of entities, bodies or persons, to which we may disclose personal information, is available in the ASIC Privacy Policy.</p>
