ASID Zoonoses Conference 2026 Poster Abstract Submission Guidelines

Abstract Submission Opens: **28th January 2026**

Abstract Submission Deadline: Midnight (AEST) **Wednesday 25th March 2026**

The main theme for ASID Zoonoses 2026 is: ***"Zoonoses and the future of health for all - The cost of not listening"***

Abstracts considered for the conference must have a zoonosis(es) as the central theme. Diseases with shared environmental epidemiology between humans and animals will be considered, but preference is given to those diseases with animal reservoirs or shared infection with humans. Discussion and acknowledgment of both the veterinary and medical aspects of the disease is expected.

Abstract and author details must be submitted online using the **ASID Zoonoses 2026 Abstract Submission Portal**

- Abstracts should be thoroughly checked for spelling and grammar. No editing will be conducted on behalf of authors and abstracts will be published as submitted. Edits to abstracts will not be permitted after submissions have closed.
- An abstract must be submitted by the presenting author and only the presenting author's contact details should be used in the submission form
- Abstracts must be prepared in accordance with the guidelines below
- The panel will shortlist abstracts that are suitable for a 15-minute oral presentation. If you do not wish to be selected for an oral presentation, please indicate this during the submission process.
- Oral presentations and posters will be judged by a panel of ZooSIG committee members during the conference. There will be prizes for the best presentations in both categories.
- By submitting an abstract, the author automatically allows ASID to publish their abstract on the ASID website in the members area and in any format appropriate for the delivery of the program for the meeting.

ABSTRACT GUIDELINES

All abstracts must:

- Be prepared in Arial 11-point type only
- Single spacing should be used

- Specify all abbreviations in full at the first mention, followed by the abbreviation in parentheses, thereafter abbreviation only should be used
- Abstracts must be original and written in English
- Abstracts must NOT have a header or footer on the page
- Do not include references

All abstracts must include:

- TITLE should appear in BOLD CAPITALS
- Principal author to appear first
- Underline the name of the author who will be presenting the paper
- Use surname followed by initials with no punctuation (do not use full stops or commas between surname and initials e.g. Smith AB, Jones J, Chan L, McDonald W)
- Omit degrees and titles
- Include affiliations for each author. Use superscript numbering after the author's name to indicate affiliations

Authors will be required to indicate if they are any of the following:

- Trainee
- PhD Student
- Early career researcher
- ASID member

Body of abstract:

- Maximum length is 250 words excluding title (up to 20 words) and authors (excess words may not be printed)
- Present your work as a structured abstract with the following Subheadings: Introduction, Methods, Results and Conclusions (if relevant)
- A maximum of one figure or one table may be used
- Note: If your abstract does not conform to the guidelines, including if it is over 250 words (plus max 20-word title), it will be returned to the submitting author to revise.

DISCLOSURE OF INTEREST STATEMENT

Disclosure of Interest Statement:

Example: "The Australasian Society for Infectious Diseases recognises the considerable contribution that industry partners make to professional and research activities. We also recognise the need for transparency of disclosure of potential conflicts of interest by acknowledging these relationships in publications and presentations."

Disclosure of interest statement – Industry:

Example 1. Organisation X declares payments to his institution for investigator-initiated research from Industry Company X.

Example 2. Organisation X has received donated materials from Industry Company X. All other authors declare no competing interests.

Acknowledgement of Funding

Example 1. This study was funded in part by the Government Body X.

Example 2. Organisation X receive grant funding from the Government Body X. No pharmaceutical / Industry grants were received for this study.

Note: If accepted into the program you will be requested to include a disclosure of interest slide into your presentation or include such statements in your poster.

CONFERENCE REGISTRATION

Poster Abstract presenters will be required to fund their own attendance at the conference.

All presenters will be required to register for the conference by the **Early Bird date, 22 May 2026**. Any presenter not registered by this date will be removed from the program.
