

## **Abstract Terms and Conditions**

Please read this information carefully before submitting an abstract. When submitting your abstract, you will be asked to indicate whether it is a scientific (original research) or non-scientific abstract (case study, literature review, clinical audit etc). Please read this document so you are clear about each of these types. By submitting an abstract, you have agreed to these terms and conditions.

#### For Scientific Abstracts:

The abstract must be structured under the following headings: Introduction, Methods, Results, Conclusion and References.

#### For Non-Scientific Abstracts:

The abstract should describe a clinical situation, issue, or practice with adequate reasoning and evidence to support a point of view. For commentary, it is not necessary to provide headings. Case studies must be structured under the following headings: Introduction, Case Presentation, Management and Outcome, and Discussion.

# For Case Race Abstracts:

Case Race Abstracts do not need to follow a structured format, but should clearly outline the case, its significance, and potential takeaways for the audience.

### **Presentation types**

Authors will also be required to indicate their preferred presentation format when submitting an abstract, either **Oral, Case Race** or **Poster**.

Oral presentations will be 15 minutes (11 minutes + 3 minutes Q&A + 1 minute for introduction). Longer presentation formats are also available. To request a longer presentation duration, please email <a href="mailto:conferences@asmirt.org">conferences@asmirt.org</a> before the submission deadline. These requests will be considered by the Scientific Program Committee **prior** to the release of the program, based on topic relevance and program availability.

Case Race presentations are a fast-paced format featuring a 4-minute presentation, 4–6 slides, and a rapid 1-minute Q&A about an interesting case, innovative process or patient experience.

Posters will again be presented as physical posters in 2026 using the design concept as in previous years, allowing delegates to more easily identify the content and outcomes of the work and thus allow for more engagement and efficient learning outcomes. If your abstract is accepted as a poster presentation it must be submitted on one of the poster templates provided. The Australian Society of Medical Imaging and Radiation Therapy (ASMIRT) will print and display all accepted posters at the conference venue.

#### **General**

- You grant the Australian Society of Medical Imaging and Radiation Therapy (ASMIRT) non-exclusive rights to publish, reproduce, distribute and store the abstract.
- Research, audit or quality improvement (QI) projects involving humans and animals must comply with ethical standards both nationally, Australian Code for Responsible Conduct of Research (2018), and internationally, such as the Declaration of Helsinki. Authors must also comply with research and QI ethics guidelines from their local human research ethics office.
- To ensure the integrity of the double-blind review process, please remove any mention of hospital/university/workplace from your abstract and title.
- Patients reported in case studies must be **de-identified**. Authors must also comply with the hospital's policy of obtaining permission from the patient or their carer.
- **Trade names cannot be mentioned in the title.** However, trade names in brackets will be accepted in the body of the text.
- If the author(s) have any commercial interests or associations that might pose a conflict of interest regarding this submission, they must be declared at the end of your abstract submission.
- If accepted for presentation, the commercial interest or association must be declared on the title slide or the slide immediately following the title slide.
- The author is responsible for the accuracy of the abstract.
- Authors may submit more than one abstract.
- Abstracts should use the Vancouver referencing style.
- The submitting author confirms that all listed co-authors have provided their consent to be included and have reviewed and approved the final version of the submitted abstract.

- Presenters are encouraged to design their presentation content and delivery to be inclusive and accessible, including use of clear fonts, high-contrast visuals, and concise language.

### **Abstract Format**

- Abstracts must be uploaded into the text box through the presentation portal in the abstract submission system. Please note there is a **special characters keyboard** available for superscript in your abstract and references.
- The total length of the abstract should be up to 250 words.
- Speaker bios should be entered, written in the third person, and are limited to 100 words. Bios will be included in the Conference App however **only the first sentence** will be used as the speaker's introduction at the conference.
- One graph, table, figure or supporting image can be uploaded at the time of abstract submission if it is essential for the overall understanding of the abstract. The graph, table or figure must be referenced in your abstract and labelled accordingly.
- References should be included if they support the abstract. These references are not included
  in the 250-word count and must be directly cited in the abstract using the Vancouver
  referencing style. <a href="https://quides.lib.monash.edu/vancouver-2022">https://quides.lib.monash.edu/vancouver-2022</a>
- Abbreviations should be defined at first mention.
- Please ensure that your abstract does not contain spelling, grammatical or scientific errors. No
  corrections are possible after your abstract has been submitted for review, unless requested
  by the reviewer/s.
- The abstract will be reproduced as submitted, though ASMIRT reserves the right to make small alterations to grammar and compliance with publication styling.
- Once an abstract has been successfully submitted you will receive a confirmation email. We encourage you to **keep a copy** of the abstract you submitted for your reference.



#### After the Submission

The reviewers will assess the abstracts using the following criteria (please see abstract marking rubric):

- relevance to the conference theme/s
- standard of reporting and English language
- clarity and readability of the abstract
- title reflects the content of the abstract
- methodology is suitable for the objectives
- point of views are supported by reasoning and evidence
- conclusions confirmed by objective results
- complying with ethics standards
- scientific value
- potential clinical value
- · originality and novelty of the work

Please refer to the <u>abstract marking rubric</u> for further detailed information regarding each of these criteria.

Using the email address provided during submission, the **submitting author** will be notified as to whether their abstract has been accepted. If accepted, authors will also be informed that their presentation will be a Poster or an Oral presentation. Specific dates and times of the Oral presentation will be provided ASAP, once the program is completed.

Submitting authors will be notified mid-November 2025 of their acceptance to present at the conference and will be required to confirm by late-November 2025 that they will attend the conference and present their presentation.

If you need to withdraw your abstract, a written statement reflecting the reasons for this decision must be sent to: conferences@asmirt.org.

### **Review and Selection**

Abstracts will be double blind reviewed by a panel of experts selected by the Scientific Program Committee.

Selection will be based on the abstract review scoring criteria as well as the overall relevance and suitability to the conference theme. The decisions of the review process are final and cannot be disputed.

# **Presenter Registration**

A condition of abstract acceptance is that at least one of the presenting authors must register to attend as a full delegate and pay the appropriate registration fee by **Thursday 11 December 2025**. Should one of the presenting authors not register by this time, the presentation may be removed from the program. A co-presenter is permitted on the basis that they have registered for the day of their presentation. Where there is more than one presenter, it is important that the presentation time is strictly adhered to, so enough time is available for questions.

#### **Publication Policy**

All abstracts accepted for presentation (Oral and Poster) will be published in the official abstract book of the conference. It is envisaged that this will be through a JMRS (<u>Journal of Medical Radiation</u>



<u>Sciences</u>) abstract supplement and will be available through the Conference online system. As this is published in JMRS you need to ensure that local and international ethical standards are complied with.

# **Recording of Presentations**

All oral presenters/authors agree to have their presentation recorded and applicable resources available through ASMIRT's online platforms. This agreement is non-exclusive and royalty-free. Presenters/authors confirm that they have the rights to share the content and acknowledge that ASMIRT is not responsible for the content of the material presented.

If any presenters/authors are unable to agree to this, they must contact <a href="mailto:conferences@asmirt.org">conferences@asmirt.org</a> with an explanation and request consideration for an exemption. Any approved exemptions will be confirmed in writing.

## **Privacy**

By submitting an abstract presenters give permission for their name, bio and image (if uploaded) to be available through the Conference App / online system, and in delegate or sponsor lists.

## **Plagiarism**

ASMIRT regards plagiarism as serious professional misconduct. If plagiarism is identified, the abstract and any other abstracts submitted by the same author will be rejected.
