

# National Professional Driver of the Year

## Conditions of Entry

In submitting this nomination, the person making the nomination affirms they have complied with the following conditions of entry:

- Nominees for the award must be full-time professional employee drivers or truck owner/operators currently working as a local, medium or long-distance driver.
- Nominations can be made by anyone, but self-nominations will not be accepted.
- A minimum of 7 years continuous experience as a professional driver.
- A good driving record with a demonstrated focus on safety, attested to by a copy of a road agency traffic record that must be submitted with the nomination.
- One or more signed references from authoritative sources, such as the nominee's fleet manager or chief executive must accompany the nomination.

# *Nominations for this award close at 11pm (Canberra time), Friday 28 February 2025 and will not be accepted after the closing date.*

## **Selection Criteria**

This section is an integral part of the judging process. The ATA along with the National Trucking Awards Judging Panel encourage and urge nominators to provide detailed responses to each section and to pay close attention to the requirements for supporting documents and files.

- A strong interest in furthering the professional image of the industry, as demonstrated by their actions and interests.

#### **Supporting Documents and Files**

- □ Nominations must be accompanied by a good quality, electronic photograph that can be used for publicity purposes (head and shoulders).
- □ Nominations must include one or more signed references from authoritative sources, such as the nominee's fleet manager or chief executive.
- □ Nominations must include a copy of a road agency traffic record.

#### Judging process

Finalists may be required to participate in a teleconference call with the judging panel in March 2025.

The winner will receive \$5,000 cash, a trophy, and will also be hosted to attend Trucking Australia 2026, including the ATA Foundation Sponsors' Gala Awards Dinner.
