Michelle Rowland MP was sworn in as Australia's 40th Attorney-General on 13 May 2025.

As the nation's First Law Officer, she is deeply committed to upholding the rule of law and ensuring Australia's legal and justice systems remain equitable, accessible, and continue to operate with integrity.

Before entering Parliament, Michelle built a distinguished career as a senior lawyer specialising in media, technology, and telecommunications.

Michelle was first elected to Parliament in 2010 and has since held key ministerial and parliamentary roles.

In 2013, she was appointed Shadow Minister for Citizenship and Multiculturalism, alongside serving as Shadow Assistant Minister for Communications.

In October 2015, she was elevated to the Shadow Cabinet as Shadow Minister for Small Business and Shadow Minister for Citizenship and Multiculturalism.

Following her re-election in July 2016, Michelle was appointed Shadow Minister for Communications, a role she maintained after being re-elected again in May 2019.

In June 2022, Michelle was sworn in as Minister for Communications. Upon the return of the Albanese Government in May 2025, Michelle was appointed Attorney-General.

Michelle is married to Michael, and together they have two young daughters, Octavia and Aurelia.



**Brendan Thomas**Chief Executive Officer
AUSTRAC



Mr Brendan Thomas commenced his 5-year appointment as AUSTRAC Chief Executive Officer (CEO) on 29 January 2024.

As AUSTRAC CEO, Brendan leads Australia's financial intelligence unit and anti-money laundering and counter-terrorism financing (AML/CTF) regulator.

AUSTRAC's regulation hardens the financial sector against criminal exploitation and its intelligence provides crucial information to its national security, domestic and international law enforcement partners.

Brendan is AUSTRAC's representative on the ACIC Board, the Serious Financial Crime Taskforce CEO Board, and the Criminal Justice and Law Enforcement Forum. In view of AUSTRAC's role as a member of the National Intelligence Community (NIC), Brendan is also responsible for agency head-level engagement with the Office of National Intelligence and other NIC members.

Brendan is a Wiradjuri man, with significant experience in leading, designing and delivering major public services, especially in the criminal and civil justice systems in NSW, and in leading organisational reform.

Ahead of his commencement with AUSTRAC, Brendan served as a Deputy Secretary at the NSW Department of Communities and Justice, with responsibility for implementing major changes to reduce the overrepresentation of the Indigenous population in the NSW criminal and child protection systems. Prior to this, Brendan was the CEO of Legal Aid NSW and was formerly the Deputy Secretary at the NSW Department of Justice.



lain Anderson

Commonwealth Ombudsman

Office of the Commonwealth Ombudsman

lain Anderson was appointed as the Commonwealth Ombudsman from 1 August 2022 for a 5-year term.

As the Commonwealth Ombudsman, Mr Anderson is also the ACT, Defence Force, Immigration, Law Enforcement, National Student, Private Health Insurance, Overseas Student, VET Student Loan and Postal Industry Ombudsman.

As a senior public servant with extensive leadership experience and over 32 years of service before his appointment, Mr Anderson developed and implemented transformational change across a wide range of legal and social policy areas, including the Commonwealth civil justice and criminal justice systems, family law, native title, Royal Commissions and Australia's territories.

Mr Anderson worked in 6 different Commonwealth departments and agencies, including acting as Secretary of the Attorney-General's Department for an extended period.

He is a Director of the Australasia and Pacific Region of the International Ombudsman Institute and is on the Board of Directors of the Institute.

Mr Anderson holds a Bachelor of Economics and a Bachelor of Laws from the University of Sydney.



Natalie Wade
Associate Commissioner
NDIS Quality and Safe Guards Commission



Natalie Wade is a pioneer in advancing disability rights committed to driving systemic change and ensuring equality for people with disabilities. In October 2024, she was appointed as the Associate Commissioner of the NDIS Quality and Safeguards Commission. Prior to this, she was the Founder and Principal Lawyer of Equality Lawyers, providing expert legal representation to people with disabilities and their families. In 2023, Natalie delivered Australia's inaugural Disability Leadership Oration with a brief to 'set the national agenda'. Her oration focused on ending the segregation of disabled people in all settings, but especially housing, through disabled leadership.

Natalie is regarded as one of Australia's foremost disability human rights lawyers and was appointed to lead the first reform to the National Disability Insurance Scheme in response to the NDIS Review, through the NDIS Provider and Worker Registration Taskforce. The taskforce provided 11 recommendations and 10 implementation actions to the Government on a proposed system of regulation for NDIS providers and workers. Natalie's contributions span across law reform and human rights campaigns advancing the rights of women and girls with disabilities, migrants with disabilities and leading advocacy for a Human Rights Act in South Australia.

Natalie authored Disability Rights in Real Life, a disability rights law handbook for people with disabilities and represented Australia at the United Nations Conference of State Parties to the Convention on the Rights of Persons with Disabilities (16th session). In recognition of her contributions, she was named Australian Young Lawyer of the Year in 2016 and more recently was awarded the 2024 Dennis Mutton Leadership Award.

Bronwyn is the Chief Counsel of the Department of Social Services (DSS) where she works in support of programs and services to improve the economic and social wellbeing of individuals, families and vulnerable members of Australian communities. Prior to joining DSS in 2021, Bronwyn spent two decades as a lawyer in the Army training, educating and advising senior ADF commanders on legal issues impacting military operations in Australia and overseas. She was also the General Counsel of the Department of Veterans' Affairs from 2019 to 2021 with responsibility for legal matters as part of the Department's mission to support veterans and their families.

Bronwyn is committed to her role as a government lawyer as part of Australia's legal system in designing and applying the rules which regulate our society, and cares deeply about institutional integrity and the responsibility of government to protect and promote the interests of all Australians.

Belinda Churnside is a proud Ngarluma woman, born and raised on Ngarluma Ngurra, where she continues to live on Country today. A passionate advocate for her culture and people, Belinda has twice served as Acting CEO of the Ngarluma Aboriginal Corporation (NAC).

She currently holds directorships with both the Ngarluma Aboriginal Corporation and the Murujuga Aboriginal Corporation (MAC), where she also serves as Deputy Chair. Belinda is a founding member of the Ngarluma Green Energy Working Group and Director of the newly established Ngarluma Green Energy Company. Managed entirely by Ngarluma Traditional Owners and focused on sustainable and community-led development of large-scale renewable energy.

Belinda has been a key advocate for the recognition of Murujuga as a UNESCO World Heritage Area and played an instrumental role as a representative on the World Heritage Committee. With over 15 years of corporate experience, her expertise spans executive leadership, management, cultural heritage, and negotiations.

Carla McDonald is a proud Aboriginal woman, descendant of the Stolen Generations of the East Kimberley with connection to Kitja Country.

Carla is the Branch Manager of the Community
Development Program in the Jobs and Economic
Development Group within the National Indigenous
Australians Agency. Prior to this she was the Director of
Legal Services at the Women's Legal Centre ACT.

Carla started her legal career as an Indigenous cadet and government lawyer in the Attorney-General's Department before moving to the NSW South Coast where she worked in general practice law firms doing wills and estates, criminal law and family law. Carla then moved back to Canberra and became an Accredited Family Law Specialist before returning to Government as a lawyer in Indigenous Affairs within the Department of the Prime Minister and Cabinet, with carriage of sensitive historic abuse matters and class actions. Carla was also an Executive Officer to a Deputy Secretary at the Department of Health and Aged Care before moving to the Women's Legal Centre.



**Selina Walker** Co-chair, ACT Reconciliation Council



Ngunnawal woman Selina Walker is a respected emerging elder and leader whose integrity has supported Aboriginal and Torres Strait Islander people and reconciliation across the ACT.

The granddaughter of Aunty Agnes Shea, a recipient of the Order of Australia and a former ACT Chief Minister's Senior Citizen of the Year, Selina continues her grandmother's legacy of influencing and driving change with her unwavering efforts.

Since 2018, Selina has promoted reconciliation as cochair of the ACT Reconciliation Council.

As a founding member of Yerrabi Yurwang Child and Family Aboriginal Corporation, she helps improve outcomes for Aboriginal families and children, especially those in out-of-home care.

Selina advocates for Indigenous people within the justice system as a member of the ACT Victims of Crime and Justice Committee and has held roles to improve all children's educational outcomes in the Catholic school system.
