# Youth Justice Group Conferencing in the Northern Territory

- **Diversion** process functions as an *alternative* to court (as is the case with *police youth diversion* conferencing under s39 of the Youth Justice Act (YJA))
- Sentencing support functioning as an adjunct to court, with the proceedings and agreement reached at the Group Conference taken into account in sentencing (as is the case with the NT Youth Justice Group Conferencing program, under s84 of the YJA)
- Post-sentencing healing, whereby people affected by the offence meet to make sense of their experiences in a way that enables them to move forward.<sup>1</sup>

# 1. Tailored to the participants world view Program Principles

#### 1. Do no further harm

The safety of all participants is paramount.


#### 2. Work with people

Rather than doing things to or for them.

#### 3. Promote wellbeing – by:

- a) Restoring or re-setting right relations (repairing harm), and
- b) Preventing future harm.<sup>3</sup>


The process of restoring right relations is complex and requires participants to address harm and the resultant conflict both *within* themselves, and *between* themselves and others.

### The Conference

- The conference takes place in an informal setting that feels safe for both the victim and the young person.
- All participants sit in a circle, providing a sense of openness and inclusion, with the placement of each participant intended to maximise feelings of safety and support (for example, the young person and victim seated next to their respective support people).



## Outcome plans - Artworks for Victims



Hand made cross for a church that had been burgled and vandalised. Cross now hanging in the church.



An elderly lady was too afraid to attend the conference. Her husband attended and said her passion was cats. The apology painting was well received.



The victim, a prominent artist, attended the conference and asked for a painting.

# 2. Types and patterns of offending


Aggravated Robbery - Aggravated Unlawful Entre - Stealing

Unlawful Assault - Unauthorised use of a Motor Vehicle

Unlawfully caused serious harm – Property Damage – Breach of Bail

Poses Controlled Weapon - Engage in Violent Conduct

Intentionally Supplied a Substance to Another Person



# 3. Geographic & climate challenges

- Darwin to Katherine = 317.1 km
  3 hr 17 min
- Katherine to Tennant Creek = 674.6km
  6 hr 55 min
- Tennant Creek to Alice Springs = 508.2 km
  5 hr 9 min



# Case Study

Bobby



## **BOBBY**

- A Pre-Sentence referral (8 Weeks) for two offences; Damage to Property and Unlawful Entry
- Young Person lived in a remote community
- Obtained reports and spoke to relevant people
- Identified ways the young person builds trust and relationships and was advised to introduce self gradually



# Preparation

- Attended the community and met Bobbys case worker
- Made arrangements to attend a cooking program with Bobby
- Met his family and spoke to Bobby about any concerns he had about the Group Conference
- Outlined next steps and a plan forward including ways Bobby would be supported at the Conference
- Met with the Victim and conducted preparation work to ensure they felt comfortable

# The Group Conference

- Provided soft toys and emotion cards
- Group Conference still followed a similar process but instead of Bobby talking, a PowerPoint presentation was shown
- The victim accepted Bobbys apology and encouraged him to say hello if they saw each other in the community
- Since the Group Conference Bobby has;
  - Completed two more conferences
  - Works in the community at the music centre
  - Maintained a relationship with the Convenor
