# Nomination Guidelines

## Who can be nominated?

Awards will be presented to individuals, teams and companies who have made a significant contribution to legal technology and innovation in Australia. There are 16 ALTA Award categories to choose from, across four streams of Awards.

## Who can submit a nomination?

You can nominate yourself (don't be shy!) or spread the love by nominating your colleagues, team or organisation, the legal tech companies or consultants that you have worked with or the legal innovators and change makers that have inspired you.

If you are nominating someone else for an award, please ensure they agree to be nominated before submitting the nomination. ALTA will assume all nominations submitted to the nomination portal have been agreed to by the nominee.

## When do I need to nominate?

Nominations are now open and close on 31 October 2022.

## When will finalists and winners be announced?

Finalists and winners will be announced at the ALTA Awards ceremony on Monday 14 November 2022 from 6 – 8.30pm at the Sydney Hilton.

## What do winners/finalists receive?

Aside from some well-deserved recognition and the opportunity to celebrate a job well done, winners will receive a trophy and 2022 ALTA Award winner logo for display on website/profile. Winners will also be featured in the ALTA Awards webinar series that will be held post-event. Finalists will receive a certificate and finalist logo. Sponsors may also provide prizes for their categories

# Nomination Guidelines

## What do I need to include in the nomination?

The nomination process is simple. You need to include:

- Short description of the project/individual you are nominating
- Short statements addressing the judging criteria for the category
- A link to a 2–3-minute video explaining why your nomination should be selected as the winner.
- Information about the nominee and nominator.

## What is the judging criteria

For each category there is two key criteria that will be used by the judges to evaluate each nomination. The criteria for each Award category is different and reflects the description for the Award. The description and judging criteria for each category is detailed in the next section.

## The Judging Process

The judges' decision is final, and no correspondence will be entered into. ALTA reserves the right not to award a category if the judges believe the nominees are not of a suitable standard. The judges may contact nominators or nominees to seek further clarifying information from nominees where necessary.
