By attending an APPA event, you agree to the below Terms and Conditions:

1. Conditions of Entry

- a) APPA Trade Shows are trade-only events and not open to the general public.
- b) APPA Trade Shows are open to APPA members and pre-approved non-members.
- c) Member and non-member suppliers are not permitted to attend APPA trade shows unless exhibiting.
- d) All prospective trade show attendees must pre-register online through APPA's event registration portal.
- e) Registered distributors will receive a barcode to present at the registration desk upon entry to the show.

2. Safety and Security

- a) APPA will not be held accountable or liable for any damage, loss, harm or injury sustained by trade show attendees during the event.
- b) APPA reserves the right to refuse entry or remove any person from the trade show who is selling products and /or services without the prior approval of the Association.
- c) Attendees agree to conduct themselves in a safe and appropriate manner at the trade show.
- d) Verbal or physical violence/aggression will not be tolerated at the trade show. Any patron in breach of this term will be expelled and at risk of exclusion from all future APPA trade shows.

3. COVID-19

- a) As the event organiser, APPA is required by law to implement certain COVID-Safe procedures and protocols at the trade show. These will vary from state to state (in accordance with state legislation) and may require you to wear a mask, check in using a QR code or provide proof of vaccination (or a valid medical exemption) prior to entering the venue.
- b) Guest tickets will not be available for purchase, allowing APPA to safely control visitor numbers and contact trace where required.
- c) If you feel unwell or have symptoms of COVID-19 please do NOT attend the trade show. Please isolate, get tested and follow instructions from the Department of Health.

4. Privacy

- a) APPA collects and uses the personal information provided by trade show attendees to communicate important information and conduct surveys/research after the event. - b) APPA may contact you on behalf of external business partners about a particular offering that may be of interest to you.
- c) APPA will not sell your information to any third party.
- d) By allowing anyone other than APPA or exhibitors to scan your name badge you agree to allow access the personal information stored on that badge and subsequently release.

5. Photography and Videography

- a) All photography and/or video recording is strictly prohibited at the trade show.
- b) Attendees consent to be included in official photographs and videos taken by event photographers and acknowledge that these assets may be used by APPA in post-show communications and promotional material.

6. Unavoidable Occurrences

a) APPA strongly recommends that patrons obtain their own adequate insurance against any foreseeable loss (including flights and accommodation for interstate travellers) in the unlikely event that the trade show is cancelled or postponed.

7. Exclusion of Liability

a) Trade show attendees are responsible for their own person and property while attending the trade show. APPA will not be held liable for loss or damage of any kind sustained during the show.
