

CAUTHE 2021 Terms and Conditions

These terms and conditions (“T&Cs”) form part of your online registration (“Online Registration”) for the CAUTHE 2021 conference online (“CAUTHE 2021”). By completing and submitting your Online Registration and ticking the relevant box as part of the registration process, you agree to be bound by these T&Cs.

1. CAUTHE 2021

1.1. You are responsible for ensuring you have the appropriate facilities, equipment and internet connectivity to access CAUTHE 2021.

1.2. You must always behave in a professional and appropriate manner at our event and must not engage in any behaviour contrary to this. This includes, but is not limited to, trying to exhibit without registering as an exhibitor or sponsor, marketing your business without registering as an exhibitor or sponsor, bad behaviour or protest.

1.3. During the course of CAUTHE 2021 you may not: (i) perform any activity or cause or permit anything that is reasonably likely to be disruptive or dangerous to CAUTHE, any exhibitor, sponsor, or any other delegates or attendees; or (ii) conduct or pursue any illegal or offensive activities.

1.4. Unless you have registered as a sponsor or exhibitor, you may not sell or display any goods or services or distribute any materials at CAUTHE 2021.

1.5. We reserve the right to deny access, or require a person already admitted, to leave CAUTHE 2021 without refund, liability, or compensation should the attendance of such individual be determined illegal, disruptive, inappropriate or potentially a legal or reputational liability, or inconsistent with these T&Cs. Furthermore, we reserve the right to require an individual to leave CAUTHE 2021 at any time for any reason or no reason, in our sole and absolute discretion.

2. Payment of the Registration Fee

2.1. This clause 2 only applies where a registration fee for attending CAUTHE 2021 is indicated as part of your Online Registration (“Registration Fee”).

2.2. You agree to pay the Registration Fee as detailed in your Online Registration and in accordance with these T&Cs. The Registration Fee, unless otherwise stated, is inclusive of all charges, duties, taxes or similar charges.

2.3. Where you have completed an Online Registration, you must make immediate payment via credit card in the "Payment" section of the Online Registration before submitting your registration or make alternative arrangement for payment within 10 business days of the conference.

3. Cancellation/Postponement

3.1. Subject to the limited circumstances set out in clause

3.2. All bookings are non-cancellable, and any Registration Fees paid are non-refundable.

3.2. In the unlikely event that we have to cancel CAUTHE 2021 if, for example, delegate numbers are too low to run the event, we will give you as much notice as possible, and you will be given the option of a refund or transfer to an alternative event.

4. Non-attendance

We are not liable to you for any non-attendance for any reason. If you are unable to attend CAUTHE 2021, event presentations will be available after the conference. Please consult the Event website or contact us for further details.

5. Circumstances outside our control

We will not be liable to you for any delay, defect or deficiency in performing our obligations under these T&Cs to the extent that such delay, defect or deficiency is caused by an event beyond our reasonable control. This includes (but is not limited to) acts, defaults or omissions of our suppliers or subcontractors, unavailability of the CAUTHE 2021 platform, a strike, lock out or other form of industrial action, outbreak of hostilities, riot, civil disturbance or acts of terrorism; pandemic, epidemic or other health emergency; fire, explosion or flood; or theft and malicious damage.

6. CAUTHE 2021 program changes

We will use reasonable endeavours to avoid changes in advertised CAUTHE 2021 program. However, from time to time amendments may be required, for example as a result of changes to speakers' circumstances or corporate change. It is your responsibility to check the status of the CAUTHE 2021 program.

8. Data protection

8.1. We will process the personal data you provide in your Online Registration in accordance with our Privacy Policy.

8.2. You understand that by choosing to attend CAUTHE 2021, you have the option to provide exhibitors or sponsors with your personal data (as disclosed when registering). With your consent, your personal data will be transferred to an exhibitor or sponsor, who may be outside CAUTHE 2021, and they may contact you about their products or services. On disclosure of your personal data, the exhibitor or sponsor becomes the data controller of that personal data and is responsible for compliance with relevant data protection laws.

9. Photography and Social Media

9.1. Release of images

If you choose 'yes' to the option to release your images in the registration form, you confirm that you have read and agree with the terms of the [CAUTHE 2021 Release of Image Permission](#).

9.2 You must adhere to and be guided by the key principles of the [CAUTHE social media policy](#) code of conduct.

9.3 You must not take photographs or otherwise film or record content within CAUTHE 2021 or of any presentations without CAUTHE's written approval.

9.2. You may not tag or otherwise discuss on any social media platforms any person at CAUTHE 2021 without their permission or unless it is expressly for the social media competition.
