### TERMS & CONDITIONS

#### Payment Terms

- (1) Full payment must be received at the date of registration to secure your ticket.
- (2) For online credit card bookings, you will receive an email confirmation with an enclosed tax invoice post payment.

#### Cancellations/Refunds

- (c) within 2 weeks of the event, you will not be entitled to a refund, however, you may transfer your ticket to another person.
