DELEGATE PROFILE

A wide spectrum of the industry is represented at the conference with over 130 delegates in attendance in 2019. The conference now enjoys significant support from all sectors of the industry from growers, storage operators, end users, traders, research, product and chemical manufacturers and service providers such as fumigators and transport operators. This conference is also widely supported by the government.

The program and topics are being expanded in line with this development and in direct response to survey feedback received from previous conference attendees.


The delegate survey from the 2019 Conference highlighted:

The 2020 was a virtual event and good feedback was received, but in person meeting was preferred by most delegates.




