- Assess potential requirements for additional standards or specifications needed to support delivery of quality TVC services in a complex, rapidly changing environment;
- Identify scope and initiate revision of ISO 13131:2021 Health informatics Telehealth services -- Quality planning guidelines:

- Identify and report on stakeholder needs for development of one or more companion standards to ISO 13131 to support conformity assessment of TVC services appropriate to the diversity of such services; and
