#### REGISTRATION TERMS AND CONDITIONS

By registering for WiT Queenstown 2026 ("Conference"), hosted by Technology Queenstown Limited ("TQL" or "we"), each attendee ("Attendee" or "you") agrees to be bound by, and comply with, these Terms and Conditions. It is your responsibility to read and understand these Terms and Conditions.

#### **Terms and Conditions**

# 1. Registration (Tickets)

A registration gives an Attendee access to the Conference content and Conference features described at the time of purchase. Registration does not include access to any other activities, sessions or events unless otherwise specified. Registrations (and tickets) may not be shared. TQL and Conference venue staff reserve the right to remove anyone suspected of sharing a registration, and no refunds will be granted.

All fees are subject to change from time to time without notice, provided that any such changes will be applied only to registrations confirmed after the changes have taken effect. The Conference program is subject to change without notice. Unless required by law or as set out in these Terms and Conditions, tickets cannot be refunded, exchanged or cancelled once issued.

### 2. Variation to Terms and Conditions

We may amend these Terms and Conditions from time to time by updating them. If we make a change that materially affects your rights or obligations, we will notify you using the contact details you provided upon registration. If you do not agree to the materially updated Terms and Conditions, you may cancel your registration and we will refund the ticket price paid by you.

# 3. Behaviour and Safety

You must comply with all reasonable instructions given by TQL or Conference venue staff, any security protocols in place at the Conference venue as well as any applicable health and safety or security regulations.

The provision, sale, or service of alcohol at the Conference will be conducted in accordance with all applicable laws, health and safety requirements and regulations. Attendees are expected to consume alcohol responsibly. TQL and Conference venue staff reserve the right, at their sole discretion and without refund, to refuse the service of alcohol, or remove, or deny entry to, any person from the Conference, who appears intoxicated, behaves in a disorderly, disruptive, unsafe or unlawful manner, or otherwise compromises the safety, wellbeing or enjoyment of others.

# 4. Cancellations and Transfers of Registration by You

All registration fees are non-refundable, except as required by law or as set out in these Terms and Conditions. No credit or refund will be issued for unused registrations.

A registration is personal to the Attendee and may not be transferred, sold or offered for resale at a premium, or used for advertising, promotion, competitions, trade promotions or other commercial

purposes. Any registration obtained in breach of these Terms and Conditions may be cancelled without a refund and you may be refused admission to the Conference.

### Conference Changes and Cancellation by TQL

We reserve the right to close, alter, postpone or cancel the Conference or other items relating, directly or indirectly, to the Conference (including, without limitation, to the Conference programme, speakers, venue or format) for any reason, in our sole discretion.

If the Conference is postponed, your registration will be valid for the rescheduled Conference, unless otherwise notified.

If the Conference is cancelled, you will be entitled to a refund of the ticket price paid by you. Refunds will be processed to the original payment method.

If the Conference is cancelled or postponed and you are unable to attend the rescheduled Conference, TQL will not be liable for any other costs, expenses, damage or loss you incur in connection with the Conference.

### 6. Liability and Indemnity

To the maximum extent permitted by law and as otherwise set out in these Terms and Conditions, TQL does not accept any liability for any loss, damage, cost, expense or claim of any kind, whether direct or indirect, arising out of or in connection with your attendance at, or inability to attend, the Conference.

Nothing in these Terms and Conditions is intended to limit your rights under the Consumer Guarantees Act 1993, or any other rights that cannot lawfully be excluded under New Zealand law.

You agree to fully indemnify and hold TQL harmless from and against all damages and liabilities arising out of or in connection with your breach of these Terms and Conditions or your negligence, misconduct or unlawful acts or omissions in connection with the Conference.

### 7. Use of Personal Information and Registration Information

We are committed to data privacy and protecting your personal information. By registering for the Conference and submitting your email address during the event registration process, you agree that TQL and its Conference partners may send you Conference related information. A valid email address is required for all registrations. We collect the information you have entered into your registration form in order to provide you with access to the Conference and materials for your use during and after the Conference for which you have registered, and for administering participation in the Conference. This may include information about the Conference's content, event logistics, payment, updates, and additional information related to the Conference. By registering for the Conference, you consent and agree that (i) we may use this information to provide you with communications about products and services related to the Conference and its subject matter; (ii) we may share this information with Conference sponsors, third-parties conducting or organising activities and/or participating in the Conference, and any third-party service providers engaged by TQL (including, but not limited to, Northstar Travel Media Singapore Pte Ltd) to assist in the conduct of the Conference, who may use this

Except as described herein, we will not disclose an Attendee's personal data to any other third party without your consent except where required to do so by law.
