Jennifer Goralski, MD is an Associate Professor of Medicine and Paediatrics at the University of North Carolina at Chapel Hill, North Carolina, USA. A/Prof. Goralski provides clinical care to CF patients of all ages and serves as Co-Director of the UNC Adult Cystic Fibrosis Clinic.

She is heavily involved in CF research and has sustained research funding from the National Institute of Health as well as the CF Foundation. She has authored over 30 manuscripts in the field of CF and conducts multicentre clinical research in CF through the Therapeutics Development Network branch of the CF Foundation. She was a lead investigator on the VX20-445-111 trial of safety and tolerability of TRIKAFTA in preschool children ages 2-5 and was the first author on the subsequent publication in the American Journal of Respiratory and Critical Care Medicine.

A/Prof. Goralski currently serves as the US national principal investigator for the VX22-445-112 study, evaluating the long-term safety and efficacy of TRIKAFTA in CF participants aged 2 years and older.
