# The Honourable Justice Dina Yehia, Judge, Supreme Court of New South Wales

Her Honour was admitted as a solicitor in 1989 and worked with the Western Aboriginal Legal Service from December 1989 until September 1996. In that capacity, her Honour appeared for thousands of Aboriginal people in towns such as Bourke, Brewarrina, Wilcannia and Broken Hill. Her Honour worked as a Solicitor Advocate with the Legal Aid Commission and was called to the Bar in 1999. Her Honour was then appointed a Public Defender. Her Honour took silk in 2009 and became the first female Deputy Senior Public Defender in 2013. In 2013, her Honour appeared as lead counsel in the High Court case of *The Queen v Bugmy* and in the Special Leave application in *Honeysett*.

Her Honour was appointed a Judge of the District Court in May 2014.

Between 2019 and November 2022, her Honour was the Chairperson of Diverse Women in Law, an Organisation which has been formed to mentor women of diverse backgrounds in the profession. Her Honour is also the current Chair of the Ngara Yura Committee. The Ngara Yura Program aims to increase awareness among Judicial Officers about First Nations social and cultural issues. Her Honour is also a member of the Bugmy Bar Book Committee and Board Member of the Australian Institution of Judicial Administration (AIJA).

On 23 June 2022, her Honour was appointed a Justice of the Supreme Court of New South Wales. Her Honour was sworn in on 4 July 2022.



## Robert Hoyles, Executive Director Criminal Law, Legal Aid NSW

Rob is the Executive Director of Criminal Law for Legal Aid NSW. He is an accredited specialist in criminal law and holds an Executive Master of Public Administration from ANZSOG. He has previously been Legal Aid NSW Deputy Director, EAGP Project Lead and Solicitor in Charge of a Sydney Indictable Team. He was the inaugural Solicitor in Charge of Legal Aid NSW's Port Macquarie office and previously worked as criminal defence lawyer in Sydney private practice, with the Aboriginal Legal Service and in four regional Legal Aid NSW offices. He commenced his career as Researcher of NSW Court of Appeal. He is presently appointed to the NSW Law Society's Criminal Law Committee and Specialist Accreditation Advisory Committee for Criminal Law. He also sits on the NSW Coercive Control Implementation and Evaluation Taskforce. He is also a Graduate of the Australian Institute of Company Directors. In 2008, he represented Australia in the Lawyers Cricket World Cup in Hyderabad, India

#### Lester Fernandez SC, Barrister, Forbes Chambers

Lester Fernandez has practiced in criminal law for over 30 years. He has a trial and appellate practice, as well as a substantial practice in inquests and professional disciplinary matters.

Lester was a member of the Bar Association's Criminal Law Committee for 15 years, and was the Bar Association's representative to the Local Court.

Before being called to the Bar Lester worked as a solicitor at a children's legal service, and then at Legal Aid NSW for 10 years. He was a Law Society Accredited Specialist in criminal law. He was Chair of the NSW Young Lawyers Criminal Law Committee.

Lester is passionate about advocacy. He taught at the Bar Practice Course for 10 years, and was a member of the Bar Association's Education Committee. He is currently assisting the Bar Association with designing and implementing a program to encourage more First Nations lawyers to come to the Bar.



#### Richard Wilson SC, Senior Public Defender

Richard worked as a solicitor in private practice in Canberra, for the Western Aboriginal Legal Service in Walgett for the Sydney Regional Corporation Aboriginal Legal Service.

In 2004 he was called to the bar. At 7<sup>th</sup> Floor Garfield Barwick Chambers he practised in crime – largely as defence counsel but occasionally prosecuting for the Commonwealth.

In 2012 Richard was appointed a Public Defender and in 2018 was appointed Deputy Senior Public Defender. He took silk in 2019. In February this year he was appointed Senior Public Defender.

Richard has a keen interest in law reform and served for 17 years on the Criminal Law Committee of the Bar Association. He is presently Co-Chair of the Bugmy Bar Book Project Committee and Co-Chair of the National Criminal Law Committee of the Law Council of Australia.



#### Paul Coady SC, NSW Public Defender

Paul was called to the bar in 2008. He became a Public Defender in 2018. He was appointed Senior Counsel in 2024. Paul was previously a commercial solicitor and worked as in-house counsel for NineMSN.com.au. Paul has been a member of a number of Bar Association Committees.

He is a co-host of the 5 Cases Podcast series which provides monthly analysis of important cases for criminal law practitioners.







#### Kellie Stares SC, Barrister, Sir Owen Dixon Chambers

#### His Honour Judge Brady SC, District Court of NSW

DCJ Grant Brady SC was called to the NSW Bar n 2000 after 10 years practice as a solicitor in the ACT. He took silk in 2015. He was appointed to the District Court in February 2024. While at the Bar he specialised in criminal law and, in particular, jury trials, although he also appeared regularly in the Court of Criminal Appeal. He is the Deputy Chair of the Australian Advocacy Institute as well as the previous Course Director of the Advanced Trial Intensive for the Australian Bar Association.

He has coached advocacy for over 20 years to all levels of advocates all around Australia as well as numerous common law jurisdictions around the world including coaching at Keble College for the Bar of England and Wales (Keble), the Bar of South Africa (Stellenbosch), Hong Kong, Singapore and India. He has trained coaches in advocacy for the last 15 years.

Since being on the District Court, he has been involved in the rollout of the Pre-Recorded Evidence of Children programme across all District Courts in NSW which includes the education of legal practitioners, witness intermediaries and judiciary. Before being appointed he was involved in setting up the vulnerable witnesses workshop for the AAI which has trained legal practitioners of all experience in taking of evidence from vulnerable witnesses.



#### Hayley Dean, Solicitor Advocate, Legal Aid NSW

Hayley is a Solicitor Advocate attached to the Parramatta office of Legal Aid NSW and became an Accredited Specialist in Criminal Law in 2013. Hayley joined Legal Aid NSW, after working for both the Commonwealth and State DPP. In nearly 20 years of criminal law practice, Hayley has worked across all levels of Courts in NSW including Coronial, Children's Court, and the Court of Criminal Appeal.

Hayley has a keen interest in matters involving coercive control, having written papers and delivered close to 30 CLE's and CPD's on the topic. In 2024 Hayley was the host of the Legal Aid NSW 5-part series podcast on Coercive Control. 
Sharon has recently passed the Bar Exam and will be joining the Bar in September 2025. Sharon will be joining Forbes Chambers.

#### Her Honour Judge Beckett, District Court of NSW

Judge Beckett was admitted as a solicitor in 1990. As a solicitor her Honour worked at the Western Aboriginal Legal Service before joining the Legal Aid Commission where she was the Senior Solicitor of the Indictable Appeal Division prior to being called to the Bar. She was a Senior Policy Officer at the then Department of Attorney General between 2004 and 2005 advising on criminal law and drafting legislation. She spent almost a decade as a barrister at Forbes Chambers before joining the Public Defenders where she was appointed Deputy Senior Public Defender. She was a founding member of the Bugmy Bar Book project and remains a member on the committee. Her Honour was appointed as a Judge of the District Court in 2019. She sits on the NSW Judicial Commission Sentencing Bench Book and initiated the Parramatta West Referral List operating in Penrith and Parramatta. Her Honour is currently the presiding List Judge at Parramatta.



#### Her Honour Judge Hopkins, District Court of NSW

Judge Hopkins is one of three judges of the District Court of NSW presiding in the Walama List, an alternative procedure for sentencing Aboriginal and Torres Strait Islander persons charged with criminal offences, with aims including the reduction in the overrepresentation of Aboriginal and Torres Strait Islander persons in custody in NSW. She is the co-chair of the Walama Working Group and the Walama Users' Forum.

Judge Hopkins is the District Court of NSW's representative on the NSW Aboriginal Justice Partnership Committee, co-chaired by NSW DCJ





and the Aboriginal Legal Service NSW/ACT. She is also a member of the Independent Advisory Panel for the Bugmy Bar Book.

Prior to her appointment to the District Court, Judge Hopkins held various positions at the Aboriginal Legal Service NSW/ACT over a 25 year period, including the Principal Solicitor of Justice Projects, Policy and Practice, in which role she co-chaired the Closing the Gap Justice Targets Working Group, tasked with the design and implementation of the NSW program of work. An accredited specialist in criminal law, she lectured in crime and the criminal process at the University of NSW.

Judge Hopkins was the founder and co-chair of Just Reinvest NSW. In that role, she worked with the Bourke community on the Maranguka Justice Reinvestment Project, which was the recipient of the 2015 National Rural Law and Justice Award, with Just Reinvest NSW receiving the 2019 HESTA Community Organisation Award and 2019 Australian Human Rights Commission Community Organisation Award.

Throughout her career she served on numerous committees including the NSW Bar Association's Joint Working Party on the Overrepresentation of Indigenous People in the NSW Criminal Justice System, the Criminal Law Committee of the Law Society of NSW, the Steering Committee for the Red Cross Vulnerability Report, and as Vice President of the NSW Council for Civil Liberties. In 2017 she was named the Community Lawyer of the Year by the Women Lawyers' Association of NSW.

#### Chanel Beesley, Barrister, Commercial Bank Chambers

Chanel Beesley has been a criminal solicitor for 9 years, working for Legal Aid, private practice, and volunteering at the Aboriginal Legal Service. Chanel was the Crime Practice Manager for Coffs Harbour Legal Aid and has recently left Legal Aid to join the bar. Chanel has joined Commercial Bank Chambers at Lismore.



#### Ajoy Ghosh, Digital Forensic Expert, The Cyber Alchemist

Ajoy Ghosh is a co-founder of **The Cyber Alchemist** and a digital forensic expert who has been engaged on many Legal Aid NSW matters. The Cyber Alchemist is almost equally engaged by the prosecution and defendants and is also extensively engaged in civil matters and commissions of enquiry.

He has taught cybercrime, electronic evidence and digital forensics at the Bachelor and Master level to computer science, engineering, law and political science students at Australian and international universities, including for many years at the Australian Defence Force Academy. Ajoy's acclaimed course **Presenting IT Evidence in the Courtroom** been attended by hundreds of police and personnel from regulatory agencies, the military and lawyers.

Ajoy is currently serving his third term on the national board of Amnesty International Australia, advocating for digital rights where his focus work includes surveillance, artificial intelligence and providing safe and secure technology for activists in countries where activism makes





them a target for oppressive governments. He is also a member of the NSW Government's Artificial Intelligence Review Committee, a member of the advisory committee for the Australian Domain Name Authority and for the Australian Government's Age Assurance Technology Trial.



#### Sophie Anderson, Barrister, Commercial Bank Chambers

#### Rebecca McMahon, Barrister, Forbes Chambers

Prior to being admitted as a barrister, Rebecca was the principal lawyer of her private law firm for 10 years. She was also the managing lawyer of the Redfern office of the Aboriginal Legal Service and held positions as a criminal defence lawyer at the NSW Legal Aid Commission and a prosecutor at the NSW Office of the Director of Public Prosecutions. Rebecca is currently an Adjunct Associate Professor at the Faculty of Law, University of New South Wales.

Rebecca is the co-chair and one of the founding members of the Bugmy Bar Book project. In 2021 she was the recipient of the Terry Keaney Memorial award which recognises dedication to the profession, excellence as a criminal lawyer, commitment to clients and concern for social justice issues.



#### Dr Andrew Ellis, NSW Clinical Director Forensic Mental Health

Dr Ellis is a Forensic Psychiatrist qualified with the Royal Australian & New Zealand College of Psychiatrists (RANZCP) and the Royal Medical Colleges (United Kingdom). He is the NSW Clinical Director Forensic Mental Health responsible for the public forensic services in secure hospitals, prisons, youth justice, community and courts. He is Conjoint Associate Professor at UNSW Faculty of Medicine and co-directs the Forensic Mental Health program. He is experienced in clinical care of complex cases, academic research, teaching and training, supervision of multidisciplinary and multiagency staff, medico-legal expert evidence and administration of public forensic mental health services.







#### Dr Robyn Shields AM, Psychiatric Registrar

Dr Robyn Shields AM is an Aboriginal doctor from the Bunjalung Nation. Robyn had given representation to the Bringing Them Home Report - Human right Inquiry into the Removal of Aboriginal and Torres Strait Islander Children from their Families. She contributed the development of the first NSW Aboriginal Mental Health Policy. Robyn holds bachelor's degrees in medicine and science and a Master of Public Health. After graduating from medicine, she began her training in psychiatry. Today she continues to work in Forensic Psychiatry.

In 2013 was appointed as an inaugural Deputy Mental Health Commissioner at the newly established Mental Health Commission of NSW. She is a current Board Member for the Justice Health and Forensic Mental Health Network and is Chair of Aboriginal Health Committee.2001 Robyn was awarded The Centenary Medal. In 2004 was named a Member of the Order of Australia (AM) division for her contribution to Aboriginal mental health. In 2015 was recognised as a Westpac 100 women of Influence.



# Emma Hudson-Buhagiar, Senior Solicitor, Aboriginal Legal Services NSW ACT

Emma Hudson-Buhagiar is a proud Wiradjuri woman. She grew up on Bundjalung country before moving to study Law/Indigenous Studies at UNSW on Gadigal Land. After completing her studies, she worked as a paralegal at the Public Defenders. In 2017, she was accepted into the graduate program at Legal Aid NSW and worked in both criminal and civil law. She then moved to the Aboriginal Legal Service where her passion for culturally appropriate advocacy and access to justice were put into practice. In 2024 Emma was named First Nations lawyer of the year. Emma's current role is the Aboriginal Legal Service Senior Solicitor on the Walama List.



#### Alison Cullen, Forensic and Clinical Psychologist

Alison Cullen is an endorsed forensic and clinical psychologist and the Director of Forensic Psychologists Pty Ltd, established in 2012. Prior to being self-employed, Alison worked with the NSWPF as the Human Factors Manager as well as DCJ. Alison also has experience in running in-house psychological services across various residential rehabilitation services, including William Booth House where she and her team provided individual and group treatment for nearly a decade. She thereby comes with over 22 years' experience working within the public services arena.


**Sid Pettit**, Social Worker, Legal Aid NSW
