## Privacy and your personal information – Privacy Collection Statement

The Australian Radiation Protection and Nuclear Safety Agency (ARPANSA) has engaged Loghic Events Pty Ltd to assist organising a community information session on its behalf. Please note that this webpage is controlled by Loghic Events and is not an ARPANSA/Commonwealth Government webpage.

ARPANSA invites you to share your views on the Australian Submarine Agency's (ASA) application for a construction licence for a proposed Prescribed Radiation Facility known as the Controlled Industrial Facility (CIF) at HMAS *Stirling* at Garden Island, WA. The proposed levels of radioactivity to be managed in the CIF are less than those prescribed in the *Australian Radiation Protection and Nuclear Safety Regulations 2018* (Cth) (ARPANS Regulations) for a nuclear installation and as such the type of licence required is classified as a prescribed radiation facility. There is no requirement for ARPANSA to conduct public consultation for a prescribed radiation facility, however the CEO has elected to seek public comment for this licence application due to the level of public interest in the facility.

Your personal information is protected by law, including the <u>Privacy Act 1988</u> (Cth) (Privacy Act) and the Australian Privacy Principles, and is being collected by Loghic Events, for the purposes of conducting an online community information session on ASA's licence application.

The community information session will:

- outline the process ARPANSA will use to assess and decide the application including the way in which the agency will seek and take into account public submissions; and
- allow you the opportunity to ask questions relevant to the licence application and/or the ARPANSA regulatory assessment.

Loghic Events will collect your personal information at the time that you register for the online event via our website. Your personal information will be disclosed to ARPANSA for the purposes of the agency sending you useful information in regard to the licence application and the consultation process (e.g. reminders, updates and relevant links). ARPANSA's Privacy Policy can be found here.

The personal information collected by Loghic Events may include your full name and email address. You may use a pseudonym but will be required to provide an email address so you can register for the online community information session held via Loghic Events. If you do not consent to Loghic Events collecting your personal information, you will not be able to participate in the community information session, as we require your email address so you can participate in Loghic Events. You can submit written questions via the Q&A function. A recorded video of the consultation event will be uploaded to ARPANSA's website, but this does not include the Q&A segment of the event. You should not include information in any written questions about another individual who is identified, or reasonably identifiable. If you need to include information about another individual in your question, you should inform that individual of the contents of this notice and obtain their consent to Loghic Events collecting their personal information.

Loghic Events will collect your personal information to:

- register you for the online session including sending you updates and an invitation to attend the event
- send you reminders of the event
- analyse the input and results of the session
- refer your question/s to the speakers at the session
- · retain transcripts of what was said during the session.

We will not use or disclose personal information without your consent, except where authorised or required by law.
