The Important Stuff

What you need to know and acknowledge before you register:

- If you're going to attend and participate in Congress and its Exhibition you must register. No matter how many of you are coming along, each person must fill out their own registration form unless part of a Practice Registration – which will be made available shortly.
- You must register as the profession you hold i.e. if you're a dentist, you must register as a dentist. That goes for partners or spouses with professional qualifications.
- Students – you need to have a valid ID card at the time of Congress.

Group and Practice Registration

Group Bookings (coming soon...)

- You must have a minimum of 3 delegates to organise a group booking.
- Group bookings of 10+ delegates will receive a discount for each delegate of the group.

- You must have a minimum of 5 practice staff members (from the same practice) to organise a practice group booking and to receive a discount for each delegate of the group.
- 5 – 9 Receive a 5% discount.
- 10+ Receive a 10% discount.
