PNG INVESTMENT WEEK CHARITY GOLF CHALLENGE

SPONSORSHIP TERMS & CONDITIONS

1. Golf Sponsorship Packages

- 1.1. All sponsorships are stated in Australian Dollars (AUD) currency. PNGCORE reserves right to alter and revise packages.
- 1.2. PNG CORE is responsible for the benefits stated in each package; any additional requests by the sponsor will be charged at cost to the sponsor.
- 1.3. Sponsors will be included in promotional materials only after full payment has been settled.
- 1.4. Sponsorship will be confirmed only after funds are cleared in the PNG CORE bank account.
- 1.5. Sponsors must provide a high-definition logo (EPS, JPEG, or TIFF) to PNG CORE.

2. Goods and Services Tax (GST)

- 2.1. A 10% GST will be applied to all sponsorships in compliance with Australian Tax Laws.

3. Conditions of Payment

- 3.1. The sponsorship application form must be completed and submitted to PNG CORE.
- 3.2. PNG CORE will provide a link for formal online booking and invoice issuance.
- 3.3. Full payment must be received by the due date on the invoice; no partial payments will be accepted.
- 3.4. The amount stated on the invoice excludes bank charges, which must be borne by the payer.
- 3.5. An application is considered incomplete until full payment is received.

4. Payment Methods

- 4.1. Payments must be made to the account specified on the invoice, referencing the invoice number.
- 4.2. Acceptable payment methods: Electronic FundsTransfer (EFT), Bank Transfer, or Credit Card (Online).
- 4.3. EFTPOS payments are accepted at the PNG CORE office.
- 4.4. Cheques and cash payments are not accepted at the PNG CORE office.
- 4.5. Bank cheques should be deposited directly into PNG CORE's bank account, with proof of remittance emailed to PNG CORE.

5. Cancellation Policy

- 5.1. Cancellations must be submitted in writing to PNGCORE with a reason for withdrawal.
- 5.2. Approval of cancellations is at the discretion of PNGCORE, considering promotional benefits received and potential for reselling the sponsorship.
- 5.3. Cancellation fees:
 - Cancellations on or after 31st October 2025: 50% of the sponsorship amount retained.
 - Cancellations on or after 31st October 2025: 100% of the sponsorship amount retained.

6. Obligations and Rights

- 6.1. Sponsors may not sublease or share sponsorship benefits with another entity without prior approval from PNG CORE.

7. Event Participation

- 7.1. All golfers must adhere to the rules and regulations set by the golf course and the event organizers.
- 7.2. Proper golf attire (collared shirts, golf shoes, and tailored shorts or trousers) is required.
- 7.3. PNG CORE reserves the right to refuse participation to individuals who fail to comply with golf course regulations or display unsportsmanlike conduct.

8. Weather Policy

- 8.1. The Charity Golf Challenge will proceed in most weather conditions unless deemed unsafe by event organizers or golf course management.
- 8.2. If the event is cancelled due to extreme weather, PNG CORE will notify sponsors and participants regarding rescheduling or alternative arrangements.
- 8.3. Refunds will not be provided for weather-related cancellations.

9. Liability and Indemnity

- 9.1. PNG CORE, the golf course management, and event sponsors shall not be held liable for personal injuries, loss, or damage to personal property during the event.
- 9.2. Participants assume all risks associated with playing in the Charity Golf Challenge and agree to indemnify PNG CORE and its affiliates against any claims arising from their participation.

10. Photography and Media Release

- 10.1. By participating in the Charity Golf Challenge, attendees grant PNG CORE permission to capture and use photographs, video recordings, and other media for promotional and marketing purposes.
- 10.2. Participants who do not wish to be photographed or recorded must notify PNG CORE in writing before the event.

11. Code of Conduct

- 11.1. All participants, sponsors, and attendees must conduct themselves respectfully towards event staff, volunteers, and fellow golfers.
- 11.2. Any behaviour deemed inappropriate, disruptive, or harmful may result in immediate removal from the event without a refund.

12. Agreement to Terms & Conditions

- 12.1. By registering for or sponsoring the Charity Golf Challenge, all parties agree to these terms and conditions. PNG CORE reserves the right to amend these terms as necessary to ensure the smooth operation of the event.
