You must be a current financial member of AIDN to submit an EOI and to exhibit at the Showcase, with your membership renewed until 2024. Showcase exhibitor booths cost **AUD \$4200 (excluding GST) each**, to cover the cost of venue hire, a personally branded exhibitor booth, event audio visual equipment and local accommodation. Due to venue space limitations, AIDN will only have capacity to showcase approximately twenty (20) AIDN member companies.

EOI applications will be assessed by AIDN National, to ensure we showcase a diverse representation of our sovereign industry capability. We are looking for a range of Australian SMEs who work both independently and together with Primes across Australia, to showcase their sovereign capability, supply chain, employment and economic contribution.

### Security

No valuable items should be left unattended at your Showcase at any time and especially not overnight. No responsibility is accepted for any loss or damage to equipment and display materials.

### **Representative Guest Passes**

Anyone from your Organisation attending the AIDN Policy Symposium & Sovereign Capability Showcase or guests you wish to invite to the AIDN Policy Symposium & Sovereign Capability Showcase must register with PPA before the AIDN Policy Symposium & Sovereign Capability Showcase. An official name badge will be required to access the Policy Symposium and Showcase area. For other sponsorship opportunities, registration will be required through the PPA online registration portal for that event.

Please ensure that all guests bring original photographic I.D. either licence, passport or photographic identity cards, no other form of I.D. will be accepted and your guests will not be permitted to be signed in without approved photographic I.D. Please allow at least 15-20 minutes once they have arrived for security processing and escorting to your function room.

### **Custom Stands**

All custom stands must fit within the purchased Showcase space. Custom stands must not exceed 3.0 metres high. If you have any questions, please email us a floor plan and elevations of your proposed stand.

### **Moving items through Parliament House**

Items that are not permitted on a domestic flight within Australia is a good guide when considering what you can bring through the front door of Parliament House. For larger items, multiple items, or items that pose a potential security risk, you must complete an APH loading dock form and return it to PPA no later than ten (10) working days prior to your event date. The APH loading dock is open for event deliveries Monday to Friday, 7am-4.45 pm only – this is non-negotiable.

### **Delegate List**

The opt-in delegate list will be supplied to eligible sponsors prior to the AIDN Policy Symposium & Sovereign Capability Showcase. The list will include name, organisation, state and email address.

### **Interactive Showcases**

Whilst we encourage you to develop entertaining and interactive displays to attract delegates, please be mindful not to disturb other exhibitors or delegates.

### **Storage**

There is a strictly limited storage space on site for Showcase equipment or packaging.

### Signage at the Venue

The venue does not allow any signage to be fixed to walls or other surfaces.

Your signage should be free standing to allow for easy placement and should be contained within your allocated Showcase space in the Great Hall.

### **Dismantling Displays**

Due to safety requirements, you will not be able to dismantle your display before the published closing time.

### Damage to the Venue

Your Organisation shall indemnify the Organisers from all liability for damage to the venue deemed to have been caused by your staff, contractors, agents, or guests. The cost of repairs will be the sole responsibility of your Organisation.
