Taronga Conservation Society Australia is a unique not-for-profit organisation and a fascinating case study for Business Studies students. In this session, participants will hear from the NSW Department of Education's Zoo Education Advisor and Taronga's Director of Education. Participants will engage in a deep dive into Taronga Education's Business Studies workshop It's Zoo Business and learn how to incorporate Taronga as a rich case study for students through excursions, incursions, or virtually. The session will include a guided tour of the Taronga Institute of Science & Learning, an innovative beacon for the future of environmental education and science, and time for participants to explore Taronga to experience 'Zoo Business' in action, just as your students would.

Keynote Speakers

Keynote 1 - A future focussed lens- Australian Curriculum: Economics and Business Version 9.0

Educators will be guided by ACARA's Curriculum Specialist HASS, Rachelle Willington, to explore how innovation is supported by the changes and refinements to the Economics and Business 7-10 curriculum content in the Australian Curriculum V 9.0. Key changes will be identified for Years 7 to 10, specifically updating of terminology, the new content in Economics and Business to strengthen consumer and financial literacy and changes to content descriptions and content elaborations through a future focussed lens. Participants will also examine the importance of skills and the interrelated nature of Knowledge and Understanding and Skills strands in the Humanities and Social Sciences learning area. The curriculum has been refined and streamlined for a dynamic future and participants will see how they can convey these transformative changes.

Rachelle Willington, Curriculum Specialist - HASS, Australian Curriculum, Assessment and Reporting Authority

Rachelle Willington, Curriculum Specialist, Humanities and Social Sciences, Australian Curriculum, Assessment and Reporting Authority (ACARA) is responsible for the Australian Curriculum: Humanities and Social Sciences and the Cross-curriculum priority Asia and Australia's engagement with Asia. Rachelle led the development and review of the F–10 Australian Curriculum: Humanities and Social Sciences learning area. She has participated in several national projects including the recent Constitutional Education Fund resources project. Rachelle is an experienced educator that has worked in both P-6 and 7-10. During her career she has been a classroom teacher, HASS curriculum coordinator, curriculum adviser for the Queensland Department of Education and HASS curriculum specialist at QCAA.

Michelle Wright is the Deputy Head of the Communications Department at the Reserve Bank of Australia. As part of this role, she heads the Bank's Public Education Program, which produces resources to support economics students and teachers. She is an experienced economist, having worked in a range of economics, financial markets and financial stability roles at both the Reserve Bank of Australia and the Bank of England. Michelle holds a Master's Degree in Economics from the London School of Economics and has published research papers on macro-financial linkages and foreign exchange markets.

Alex Symonds, Public Education Economist and Economics Teacher, Reserve Bank of Australia

Alex Symonds is a Public Education Economist and Economics Teacher at the Reserve Bank of Australia. He works in the Bank's Public Education and Access Team, collaborating with RBA economists to produce materials to help Australia's economics teachers and students. Prior to joining the Bank, Alex was a high school teacher and taught senior Economics and Business Studies, as well as a range of junior subjects. As a teacher, Alex created a suite of online economics resources that have been used by teachers and students around the world.

Keynote 4 - What do the best teachers do and Panel Discussion

What do the best economics teachers in NSW do? Gavin has seen them in action, and it's a good time to find out as we head back to school after the holidays. Last year, he was given access to HSC data to identify the best performing economics teachers in NSW. He went to their schools to interview them and observe them in the classroom. While there are many evidence-based teaching strategies that can increase our impact on student learning, there were 8 specific elements that were common among most or all of the teachers and classrooms identified in my study. This presentation will be followed by a panel discussion of other premier scholarship winners.

Gavin is an experienced Economics and Business Studies teacher in NSW. He was the winner of the Premier's Reserve Bank of Australia Economics Scholarship. Prior to teaching Gavin was a Senior Policy Analyst with the Australian Department of Climate Change.
