EOI Guidelines

- Only EOI's submitted via the online submission form will be accepted.
- Submissions must be in English.
- Submissions should be text only no diagrams, illustrations, tables or graphics.
- Submissions should be no longer than 300 words.
- If applicable, authors and/or presenters must declare conflicts of interest when submitting.
- If a submission is research based, you may be required to provide evidence of ethical approval.
- The RACGP reserves the right to accept and decline submissions according to the review process.

If your EOI is accepted and offered a place in the program,

- Presenters are required to register and pay for their registration to attend the conference by a nominated date; otherwise, the presentation may be removed from the program.
- Presenters/authors are responsible for all costs associated with attending the conference, including but not limited to registration, travel and accommodation.
- All presenters are required to structure their presentation in alignment with the session type (including Question & Answer time, where applicable) and the session chair will ensure this is adhered to.
- If you are submitting on behalf of a corporate entity, please ensure you read the CPD guidelines and your presentation a hears to this

Review Criteria

EOI submissions will be reviewed by the Conference Advisory Group and scored using the following criteria to determine the overall rating of a submission.

Presentations will then be selected based on their rating, with the highest quality submissions being offered a place in the program (based on the number of sessions available in the program to be filled).

Individuals and organisations may submit multiple Expressions of Interest (EOIs) to present; however, only ONE (1) EOI per individual or organisation may be accepted to present.

The RACGP, in consultation with the Conference Advisory Group, will assess all submissions on merit and may select the most suitable EOI from a person or organisation for inclusion in the final program. This policy ensures broader participation, diversity of perspectives, and equitable representation across the program.

It is the policy of the RACGP not to release the details of those who reviewed the submissions and requests for reconsideration of a submission cannot be accommodated.

Review Criteria:

- 1. Does the submission clearly demonstrate how the presentation will provide new learnings, innovation, education or hands-on updates to GPs to be used in a practice setting?
- 2. Is the subject matter relevant to GPs and something that they see in practice setting?
- 3. Does the submission provide evidence to support the learnings, education or hands-on skill update? As an evidence-based College, it is essential that there is evidence to substantiate the content.
- 4. Will the presentation showcase new knowledge or guidance to the audience?

Program Scheduling

Program scheduling is at the discretion of the RACGP as the conference organiser.

Any request to alter an allocated time slot will be considered on a case-by-case basis with consideration of the impact on the whole program and cannot be guaranteed.

The RACGP reserves the right to approve Expressions of Interest (EOIs) to present on related topics and suggest the formation of a panel discussion. Where multiple high-scoring EOIs address similar theme or topic, the RACGP may invite presenters to participate as part of a combined panel session rather than an individual presentation.

The RACGP reserves the right to change presentation dates and times if needed. In this instance every effort will be made to find an alternative presentation slot that is suitable to the presenter.

Conflict of Interest and Disclosure

The RACGP takes the view that any potential conflicts of interest must be recognised and stated. If there is doubt about the existence of a conflict, it is preferable to err on the side of caution and make a disclosure. The intent of the disclosure is not to prohibit speakers from presenting, but to inform the audience of any possible bias that speakers may have.

Conflicts of interest (COI) are common, and some would say almost inevitable. COI are secondary interests (i.e personal, commercial, political, academic or financial) that may influence judgements of the audience receiving the presentation. COI have been described as those which, when revealed later, would make a reasonable delegate feel misled or deceived. Financial interests may include employment, research funding, sponsorship, stock or share ownership, payment for lectures or travel, consultancies, company support for staff commissioning/funding/ sponsoring of any element of the paper, any financial or potential financial benefit, or PR firm involvement. This is not an exhaustive list of potential conflicts, rather an indication of the range of potential conflicts of interest.

Disclosure must be done verbally and displayed in writing on a presentation slide at the beginning of a presentation. It may also be included in written conference materials.

Please note: The RACGP reserves the right to rescind or withdraw any submission at any time, including after publication, if undeclared concerns with authorship, conflicts of interest, plagiarism or content veracity and accuracy arise.
