

# Presenter Terms and Conditions

By agreeing to present and attend at this RACGP event, you agree to be subject to the following terms and conditions:

### **RACGP Values and Integrity**

You agree to conduct your presentation of material in compliance with all relevant laws and codes of practice and in a manner that aligns with RACGP, and its values as explained to you.

In addition, you agree that you will not interfere with or compromise the independence or integrity of RACGP and its representatives and the event purpose and goal.

Your actions and words must represent inclusivity, regarding gender, cultural background, sexual orientation, age or any other characteristic that is considered to exclude or marginalise those that have any physical or mental disabilities or those belonging to other minority groups.

## Submission and approval of presentation

You must prepare and submit to RACGP your presentation (including abstract, presentation paper, PowerPoint presentation, handouts or any other materials in connection with your presentation) for RACGP's approval.

RACGP may provide submission criteria, guidelines and templates for the submission of presentations. A presentation must be submitted to RACGP within the timeframe specified by RACGP and in accordance with any templates specified in the submission form or in any other approved format as specified by RACGP from time to time.

Your presentation must be original. If you wish to submit a presentation that is not original or has been published previously you must tell us in writing prior to, or at the time of, your submission.

Approval for you to present your presentation at this RACGP event is at RACGP's sole and absolute discretion.

#### **Costs and Expenses**

If RACGP approves your presentation, you (or at least one co-author) must present the presentation in person at the event. You must arrange and pay for any accommodation, travel and expenses in connection with attending the event and presenting your presentation. RACGP is under no obligation to pay any amounts to you in connection with the preparation or presenting the presentation.

You may be eligible to receive a discount registration to attend the event as a delegate.

# **Intellectual Property**

You agree that have all necessary authorisations, permissions approvals and consents to submit your presentation to RACGP and to make the presentation at a RACGP event.

You agree that by submitting the presentation material or making the presentation you will not infringe the intellectual property rights or moral rights of any person.

In addition, you acknowledge the ownership of all intellectual property owned, licenced or developed by any other presenter, or person or corporate connected to the event and you will be subject to intellectual property laws of ownership and will not have rights to that material.

You grant to RACGP a non-exclusive, royalty free, non-irrevocable licence to take and record, copy, reproduce or take images (digital or otherwise) of you and your presentation at the event, which RACGP may reproduce or promote on or via its website, the event website or app (including any on demand services), any printed medium and any social media, blogs and printed articles or such other method as RACGP determines, following this event.
