From frontline clinicians to community-led initiatives, these awards shine a light on those who go above and beyond to make a difference in their communities.

Presented by Rural Health West in partnership with WA Country Health Service, the Awards are a meaningful opportunity to showcase the stories and achievements shaping rural health care in our state.

WHY NOMINATE?

By nominating someone, you're not only honouring their contributions, but you're also helping to:

- Acknowledge extraordinary efforts in challenging and diverse environments.
- Inspire others through powerful examples of dedication and innovation.
- Share success stories that highlight the richness and resilience of rural health care.
- Give individuals and teams the recognition they truly deserve.
- Promote pride and visibility across the rural health sector.

Anyone can nominate! Health professionals, colleagues, community members, patients and clients are all encouraged to get involved.

NOMINATION PROCESS

Nominations open: 1 July 2026

Nominations close: 2 September 2026

To nominate, follow these steps:

- 1 Review the Award Categories and Criteria in this document.
- 2 Select the most appropriate category for your nominee.
- 3 Ensure you receive an endorsement to support your nomination.
- 4 Review the tips and tricks on submitting a successful nomination.
- 5 Submit your nomination via the online submission portal.
- 6 Your nomination (maximum 900 words) should clearly address the selection criteria and highlight the nominee.

Nominations are anonymous, and you will be contacted should we require further information.

REVIEW PROCESS

The review process is designed to ensure fairness, transparency and recognition of merit. It involves three rounds of review.

- **Initial review:** Awards organisers will read the nomination. If the nomination is lacking information or could be improved and time permits, it will be returned to the nominator with feedback. If changes have not been made by the closing date, the nomination will either be accepted or declined.
- **Round one:** Nominations are divided between six review panels. Each panel (3 members) reviews and scores nominations based on the published selection criteria.
- **Round two:** The top five scoring nominations in each category are reviewed again. Round two reviewers (3 members) will then recommend three finalists and one winner from the finalists per category.
- **Round three:** Finalists and winners are reviewed by a final review panel (2 members). They may endorse the recommendations or re-review the top five to make alternate selections.

All reviewers are health professionals, rural health stakeholders or industry representatives, invited to participate in the review process by the event organisers. Finalists will be announced November 2026. Winners will be revealed at the Awards Gala Ceremony on **Saturday 20 March 2027**.

CONFLICT OF INTEREST DISCLOSURE

To ensure the integrity of the review process:

- All members of the review process are required to declare any actual, potential or perceived conflicts of interest.
- If a reviewer has a personal or professional relationship with a nominee, they will recuse themselves from reviewing that particular nomination.
- If a reviewer recuses themselves from a nomination, that nomination will be reviewed by the Conflict-of-Interest Reviewer to ensure it still receives the full review process.

ELIGIBILITY CRITERIA FOR NOMINATIONS

Please review the below eligibility for all nominations, noting some categories also have their own specific eligibility.

- At the time of the nomination, all nominees must be delivering health services to rural and remote communities on the mainland of Western Australia, defined as MMM 2-7 locations.
- Unless otherwise stated, at the time of the nomination, nominees must have delivered services in rural WA location for more than two years.
- Nominations must be submitted by the closing date (**2 September 2026**) via the official **online portal**.
- Nominations can be submitted by supervisors, peers and organisations. We do not accept self-nominations outside of the Health Team of the Year Award.
- Community members can submit a nomination for the Health Service Contributor of the Year Award.
- All nominations must be endorsed by a colleague, supervisor or professional peer of the nominee.

CATEGORIES AND CRITERIA

ABORIGINAL HEALTH PROFESSIONAL OF THE YEAR AWARD

This award recognises an Aboriginal health professional who delivers culturally safe, responsive, and compassionate care in rural WA. They demonstrate a deep personal and professional commitment to Aboriginal health and actively work to improve health outcomes for Aboriginal communities.

Selection criteria

- Outline the nominee's career in rural health, including qualifications and service history in Aboriginal health.
- Describe how the nominee provides person-centred care by collaborating with patients, families, communities and/or healthcare teams.
- Provide specific examples of their positive impact on the health and wellbeing of the community.

Additional category specific eligibility

- Must identify as Aboriginal.

ALLIED HEALTH PROFESSIONAL OF THE YEAR

This award recognises an allied health professional who has gone above and beyond in their commitment to the health and wellbeing of rural communities. They demonstrate excellence in service delivery and active contribution to rural health.

Selection criteria

- Provide a summary of the nominee's career in rural health, including qualifications and duration.
- Describe the outstanding qualities and achievements that make this professional exceptional.
- Share examples of the nominee's contributions and their impact on the community's wellbeing.

CLINICAL LEADER OF THE YEAR

This award recognises a health professional whose leadership has driven improvements in patient care, access, or safety in rural WA. They inspire excellence, foster collaboration, and serve as a role model in rural healthcare.

Selection criteria

- Outline the nominee's career and experience in rural practice.
- Provide examples of leadership in areas such as patient safety, satisfaction or access to care.
- Describe how their leadership has positively influenced peers and improved community health.

EARLY CAREER HEALTH PROFESSIONAL OF THE YEAR

This award recognises an early career professional who demonstrates exceptional promise, leadership, and commitment to improving health outcomes in rural and remote communities.

Nominees may be at any stage of life but must be within the early years of their career in the health sector. This includes individuals who have transitioned into health from other professions or moved into a new health profession.

Selection criteria

- Outline the nominee's early career journey and rural experience, including examples of their contribution to health outcomes, service quality, or safety.
- Provide examples of how the nominee has demonstrated leadership, initiative, or a proactive approach within their role or team.
- Show how the nominee engages with the community, colleagues, or professional networks, including involvement in community or volunteer activities where relevant.

Additional category specific eligibility

- At the time of nomination, nominees must be within the first five years of practising in their current health profession in a rural or remote location.

GENERAL PRACTITIONER (GP) OF THE YEAR

This award recognises a general practitioner or rural generalist who has shown exceptional commitment to rural healthcare. The nominee consistently delivers high-quality clinical care and engages deeply with their community.

Selection criteria

- Summarise the nominee's rural career and qualifications.
- Detail how they have maintained excellence in service, including innovative service delivery models or additional clinical or procedural skills.
- Provide community impact examples that demonstrate improved health outcomes.

HEALTH SERVICE CONTRIBUTOR OF THE YEAR

This award recognises an individual working within the rural and remote health system who has made a meaningful difference to the wellbeing of individuals, families, or communities through their contribution, care, and commitment.

Nominees may include clinical professionals, support staff, administrative personnel, or others working within health services whose role contributes to positive health outcomes and experiences.

This award provides an opportunity for patients, families, carers, and community members to share personal stories that highlight the impact of the nominee's work.

Selection criteria

- Describe how the nominee has made a meaningful difference to the health, wellbeing, or experience of individuals or the broader community.
- Provide examples of how the nominee demonstrates compassion, dedication, or excellence in their role, regardless of whether their work is clinical or non-clinical.
- Explain how the nominee's actions have improved access to care, service delivery, or the overall experience for patients, families, or community members.

HEALTH TEAM OF THE YEAR

This award recognises a team or service that has delivered significant improvements to rural and remote health outcomes through collaboration, innovation, and excellence in care and service delivery.

Teams may include a mix of clinical professionals, support staff, administrative personnel, and other roles contributing to the planning, coordination, and delivery of health services.

Selection criteria

- Describe the team’s work and the measurable or meaningful benefits achieved for individuals or the broader rural community.
- Highlight how the team worked together and with other agencies, services, or community groups to deliver coordinated and effective care.
- Explain how the initiative or service has created ongoing, positive change, including improvements to access, service delivery, or community wellbeing.

Additional category specific eligibility

- Can be self-nominated.
- Open to multidisciplinary teams, including clinical and non-clinical members.
- Can be metro based but must be delivering outreach services in MMM 2–7 locations.

NURSE OR MIDWIFE OF THE YEAR

This award recognises a nurse or midwife who has consistently delivered high-quality care, exceeded role expectations, and contributed meaningfully to their rural community.

Selection criteria

- Summarise the nominee’s rural nursing or midwifery career.
- Provide examples of professional excellence and patient outcomes.
- Describe the nominee’s contributions to their community.

SPECIALIST (NON-GP) OF THE YEAR

This award recognises a medical specialist who provides exceptional care and leadership in rural WA either as a resident or visiting specialist.

Selection criteria

- Outline the nominee’s rural career and experience.
- Describe their commitment to continuity of care and mentorship.
- Provide examples of how they contribute to workforce development and teamwork.

TIPS FOR A STRONG NOMINATION

BE CLEAR AND SPECIFIC

Focus on what sets your nominee apart – avoid general statements like “they are amazing” or “everyone loves them”, instead give examples of what they’ve done that shows why they are outstanding.

ADDRESS THE CRITERIA DIRECTLY

Each award category has specific criteria. Use these as a guide and structure your nomination to respond to them. The use of headings, or highlighting which criteria point you are answering is very helpful here.

TELL A STORY

Describe real-life examples that show the nominee’s dedication, innovation or care. Bring their work to life by explaining what they did, how they did it and why it mattered. Include evidence and statistics if they are available.

AVOID JARGON

Remember, reviewers may come from a variety of backgrounds. Write any abbreviations out in full before using the shorthand eg Rural Health West (RHW).

KEEP WITHIN THE WORD COUNT

The limit is 900 words.

NOMINATION CHECKLIST

Certainly! Please do not copy and paste the nomination, as each category has it's own selection criteria.

SAMPLE NOMINATION

Below is an example nomination for a fictional nominee for the rural Nurse or Midwife of the Year category.

Word count: ~750

1 Summarise the nominee's rural nursing or midwifery career

Jane Porter has served as the sole community nurse in the remote town of Woorlup for the past eight years. In that time, she has built a trusted health hub from the ground up, expanding services far beyond what would usually be expected of a nurse in a town of 400 people.

Jane began her career with a strong interest in rural health, completing postgraduate studies in remote area nursing. She chose Woorlup as a long-term placement and has become an embedded and essential member of the community.

2 Provide examples of professional excellence and patient outcomes

Jane consistently delivers care that goes far beyond expectation. In 2025, she launched a mobile wound care service after identifying transport barriers for elderly patients. Since then, hospital admissions for wound-related infections have dropped by 60%.

During the 2024 floods, Jane coordinated Woorlup's emergency health response—organising supplies, checking on isolated residents, and ensuring culturally appropriate support in partnership with local Aboriginal elders. Her leadership helped prevent escalation of medical issues during a time of crisis.

She also pioneered a telehealth pilot connecting residents with allied health professionals, which has now been expanded regionally due to its success. Her work with the local school on youth mental health sessions has further strengthened community resilience.

Jane works tirelessly, often outside regular hours, and always with humility and professionalism.

3 Describe the nominee's contributions to their community

Jane's impact reaches well beyond clinical care. She is mentoring two final-year nursing students, helping grow the next generation of rural health

professionals. She also leads Woorlup's Health and Wellbeing Committee, advocating for practical solutions like subsidised transport and public defibrillators.

She is deeply woven into the community—known not just as a nurse, but as a trusted advocate and mentor. Her work reflects a holistic, people-first approach to rural care.

Jane Porter embodies the values of rural nursing: dedication, innovation, and community connection. Her leadership, compassion, and practical impact make her an exceptional candidate for Rural Nurse of the Year.

If all required nomination submission fields have been completed you will have the option to submit your nomination at the bottom of the page. Terms and Conditions for Nominations

1. A nominee can be entered into more than one category using separate nominations.
2. Nominees must be currently employed in WA.
3. If a nominee has been a finalist in a particular category in previous years they can be re-nominated in that category the following year.
4. If a nominee has been a winner in previous years, they can not be considered in that category again.
5. Each nomination must be endorsed by a second person (Regional Medical Director, Line Manager, Supervisor, Shire President or Practice Principal.)
6. Nominees must not be subject to a professional practice notification, restriction/limitation to practice, under investigation, disciplinary process or undergoing performance management. If a nominee is subsequently found to be subject to any of these conditions their nomination will be withdrawn.
7. Late applications will not be considered.
8. A confirmation email will be sent to the nominator once the submission is received.
9. A confirmation email will be sent to the nominee once the nomination has been accepted.
10. The Judging Panel may change the category for which the individual is nominated.
11. The Judging Panel's decision is final and no correspondence or discussion will be entered into.
