



**New technologies:** Exploring how advancements in technology (e.g. tele-health, artificial intelligence, virtual realities) are changing the landscape of counselling, psychotherapy, and mental health.

**Regional, rural, and remote health:** Addressing the unique challenges and opportunities for providing mental health support in rural and remote areas, and exploring innovative solutions.

Climate change and its impact on health: Understanding the role of natural disasters, climate change and environmental crises on mental health – its psychological impact on individuals and communities, and strategies to address eco-anxiety and trauma.

**A growing Indigenous workforce:** Discussing the place of an Indigenous workforce in the counselling profession, initiatives led to foster its growth and development, and the impacts of the 2023 Australian Voice Referendum on Indigenous people.

**Diversity and inclusion:** Examining how evolving cultural norms and increased diversity are shaping the practice of counselling, such as changing family structures, roles and dynamics, and generational differences in help-seeking behaviours and therapeutic needs.

**New specialities:** Discussing how therapeutic modalities are evolving to meet the needs of diverse populations and changing societal contexts.

**New technologies:** How new technologies change the mental health services landscape. How effectively are telehealth services being utilised? Are there effective digital tools and apps being used for mental health assessment and treatment? This includes online therapy platforms, mental health apps, and other technological innovations.

**Policies, regulation & funding:** How the Mental Health services are shaping our future, Are there supportive policies, regulations and funding in place

**Social media and self-image:** Exploring the influence of social media on self-image, body image, and mental health, and strategies for promoting healthy digital identities.

**Political and societal change impacts:** Examining the mental health impacts of political disruption, societal movements, and societal changes, and strategies for supporting individuals and communities during times of transition.

#### 4- PRESENTATION TYPES

#### 30 min Presentation (Includes 5min of Q&A)

Present to the audience providing concise, focused, and valuable insights into a specific topic, allowing attendees to gain new knowledge, perspectives, and skills within a relatively short timeframe.

#### 90 min Workshop (includes 10 minutes of Q&A)

As a workshop presenter, you are an accomplished and authoritative figure within your field, possessing extensive expertise and practical experience in your area of focus. You are a native public speaker, you know how to keep attendees' attention through engaging, interactive, and in-depth instructional sessions that offer participants a unique opportunity for immersive learning and skill development.

#### 3-hour or 6-hour Masterclass

Expert in your field, you excel at delivering engaging, interactive sessions that facilitate active learning and skill development. Your presentation should cover the topic comprehensively, offering practical and hands-on exercises for the attendees. We encourage all masterclass presenters to create a collaborative learning environment and provide personalised guidance and support to attendees as they explore new concepts and techniques. Ultimately, your presentation should equip participants with actionable takeaways that they can effectively apply in their professional lives.

The authors who are not confirmed to present at the conference will be given other opportunities, such as participating in ACA webinar series, presenting at a symposium, or submitting an article.

#### **Abstract Submission Steps and Key Dates**

- STEP1: Carefully read this guideline and policy document.
- **STEP2:** Start your abstract submission via the **event Abstract portal** you can return to edit your draft submission at any time before submitting.
- **STEP3:** Submit your abstract before the **closing date of 15 September 2024.** You will receive a confirmation email acknowledging receipt of your abstract submission.
- **STEP4:** You will receive notification by **15 October 2024** whether your presentation is accepted, on the waitlist or declined.
- **STEP5:** You will have until **30 October 2024** to accept or decline the offer by returning the signed contract.
- **STEP6:** Register to the conference as a presenter via the event website **from 15 Jan 2025** at early bird price and special discount
- STEP7: Send your PowerPoint presentation by 30 March 2025.

#### 7-EVALUATION

#### **Process**

- After the call for submissions closes, **a panel of reviewers**, including ACA peers and other experts in the profession, will access all submissions.
- Once all the abstracts have been reviewed, **the panel will select presenters for the program.**
- Authors will receive notification of their abstract status: accepted, waitlisted, or declined.
- We will have a waitlist available should there be a cancellation. You may qualify for the waitlist and potentially be invited to present in a second round of submission notification.
- And for those who will not be presenting at the conference, they will be offered the opportunity to get involved in:

  - Presenter at symposium
  - Article submission

The key evaluation criteria for submissions encompass these essential aspects:

- Topic Importance and Relevance: The significance of the topic in relation to preferred themes and current real-world concerns – Score type: From 0 to 10 -Weighting: 25%
- **Originality:** The presentation offers fresh approaches, perspectives, or evidence aimed at expanding audience knowledge and skills. Score type: From 0 to 10 Weighting: 25%
- Quality: Evaluation of the engagement level, interactivity, and practicality (for workshops), alongside evidence-based best practices, clarity of presentation, and presenter credentials. – Score type: From 0 to 10 - Weighting: 25%
- Discussion Provocation: The ability of the submission to stimulate discussion and resonate with current real-world concerns. – Score type: From 0 to 10 -Weighting: 25%
