

Registration terms and conditions

Attendee Code of Conduct

The Business Advantage Papua New Guinea Investment Conference 2026 will present opportunities to learn, share knowledge and network.

Payment Policy

It is a condition of registration that full payment is received within invoice terms (14 days) and fully paid prior to the commencement of the event.

Where payment is not received within invoice terms, organisers reserve the right to cancel the registration at their discretion.

All rates quoted are in AUD\$ and include Australian Goods and Services Tax (GST).

Cancellation Policy

Cancellation requests must be made in writing. Charges will apply for cancellations:

- Cancellations advised in writing at least 14 days before the event will receive a 50% refund of the registration fee.
- Cancellations within 14 days of the event will not receive a refund.

Registrations are transferable to a colleague at any time prior to the event provided the Registration Partners and Organisers are advised in writing.
