TF-WWF10 Agenda Item 1: Brief of the virtual meetings organized in 2024

1. Under the leadership of PH Dr. Saeed Nairizi and Vice President Alireza Salamat, the task force has organized two online meetings - 08 February and 28 March 2024. During the online meetings, the Chair discussed the potential involvement of ICID in the 10th World Water Forum and its contribution to the Sessions. The Chair/ Vice Chair will present a brief outcome of the online meetings at the meeting. TF-WWF10 Agenda Item 2: A brief report on the involvement of ICID during the 10th World Water Forum, 18-25 May 2024, Indonesia

- 2. The 10th World Water Forum was jointly hosted by the World Water Council and the Indonesian Government under the theme "Water for Shared Prosperity" from 18-25 May 2024 in Bali, Indonesia, and aimed to advance international initiatives on water and sustainable development, promoting global dialogue and cooperation on the sustainable utilization of water resources. The event drew the participation of state leaders from 11 countries and over 50,000 attendees from more than 200 nations and international bodies.
- 3. To promote ICID's role in the 10th World Water Forum, a Special Session (SS13) on "Water, Food, and Energy Nexus Using Smart Water Technologies" was organized on 21 May 2024 at the Bali International Conference Centre. President Dr. Marco Arcieri and Vice President Alireza Salamat coordinated and moderated the session. Around 10 speakers from Iran, Italy, Saudi Arabia, South Africa, Japan, China, Korea, Chinese Taipei Committee as well as international organizations including FAO, Islamic Development Bank, and the World Bank presented their contributions on various perspectives of Water, Food, Energy Nexus and Smart Water and Irrigation Management Technologies which the participants of the event all highly appreciated. Also, a Session on "Food and Water security: the role of ICID" was organized on 20th May 2024. - (c) To liaise with other International Bodies;
- (d) To regularly report to the IEC the developments in the preparatory works leading to the 11th World Water Forum and recommend ICID inputs for consideration in the 75th International Executive Council (IEC) scheduled in Australia.
- (e) To entertain activities to promote ICID's visibility in the World Water Council.
