# **Dr Gerard Clausen Abstract:**

Dentistry is foremost a profession, and second a business; correct?

Not true. Dental practice demands high levels of clinical and communication skills. But successful practice also requires an awareness of the current environment, including the various complaint bodies, regulatory authorities and other agents that may oversee the providers treatment and billing practises.

This presentation will discuss these factors, and how they impact on every dental practitioner.

# Dr Kang Kim Abstract:

The Golden Ratio of Business and Healthcare

Business and consumer behaviour is changing rapidly. Advancements in digital technology, cultural shifts and influence of social media have not only impacted broader consumer markets but has changed the way in which patients seek healthcare. To add to these steep trends, the COVID pandemic acted as a change catalyst and great disruptor to the health sector. Clinicians were forced to consult virtually and manage emergencies remotely diminishing aversions towards digital health solutions. The post-pandemic impacts on patient acuity and hospital capacity have compelled patients, as well as public and private funders, to consider the cost and sustainability of healthcare.

In this complex environment, the dental profession needs to be keenly aware of how it conducts its business. The way that we conduct business should not be different from the way that we deliver care to our patients. Our business decisions, like our clinical considerations, should be informed by facts and based on evidence. Business-driven decisions should balance in an ideal "golden ratio" with the foundational principles of healthcare and the expected ethical conduct of health practitioners.

It is important to reflect that the dental profession started in the time of stringent advertising restrictions and the regulation of dental practice ownership. The introduction of unchecked advertising, contracted provider relationships and the growth of dental corporates show how accepted behaviour has shifted in the past two to three decades. At the practice level, common accounting omissions and valuations have contributed to negative business decisions. Health economics principles and the distinction of the healthcare market from the perfectly competitive market, help us understand why caricaturised business principles need to be avoided. The continuation and further proliferation of underinformed business decision-making is likely to contribute to the commoditisation of healthcare with strong profession-wide impacts.

Cone Beam CT is an invaluable diagnostic tool in dentistry and is used extensively for diagnosis and surgical planning.

Specialist Dental Radiologists Raahib and Jake will share with you all the techniques and special tricks they use to reformat and review CBCT scans to help you become more confident when reviewing your clinical cases and planning treatment.

Participants are encouraged to bring their own laptop (Mac or PC) so that they can follow along and master the skills required to efficiently review both small and large volume scans.

CBCT viewing software and de-identified CBCT scans will be provided a few days before the workshop so that you can ensure you have everything you need to get started.

#### Abstract:

The first segment of the masterclass will examine the pharmacology of commonly used analgesics in dentistry. Emphasis will be placed on striking a balance between effective pain relief and minimizing potential risks associated with medication use.

The second segment will delve into strategies for preventing post-surgical pain. The presentation will cover evidence-based interventions such as pre and perioperative analgesia for surgical procedures, and atraumatic surgical techniques. Participants will gain practical insights into preoperative evaluation, proper dosing, and personalized pain management plans to enhance surgical outcomes and improve patient satisfaction.

Lastly, the masterclass will address the biopsychosocial model of pain, acknowledging that pain is a complex phenomenon influenced by biological, psychological, and social factors. Through interactive discussions and case studies, participants will explore how the integration of physical, emotional, cognitive, and social aspects can optimize pain management outcomes and prevent sequelae such as post traumatic trigeminal neuropathic pain. Focus will also be given to informed consent tips.
