A secure payment link will be issued once the invoice has been issued. Please note that a 4% administrative fee applies to all credit card transactions. This administrative fee will be charged separately and will not be reflected in the official tax invoice.

**Important Note**

1. Only the Official Electrical Contractor will be permitted to undertake electrical works from the source of supply up to the booth in the exhibition.
2. All prices quoted shall include local licensing fees, installation (where applicable) and power consumption.
3. Check that your equipment can operate on the above electrical specifications. Non-standard items will not be locally available. Exhibition requiring different voltage or frequency, stabilisers, or special requirements must arrange for their own transformers, convertors, boosters, stabilisers, UPS, etc. and keep the Official Contractor informed. You should bring with your adaptors or regulators if necessary.
4. Socket points are not for lighting use. If lighting fittings are brought in by the exhibitors for lighting purposes, the lighting connection charges will apply on per bulb/per tube basis.
5. Lighting connections are charged according to the number of tubes and bulbs fitted on the stand
6. Light boxes are charged according to the number of tubes in each light box, using the lighting connection or 40W fluorescent tube rate, whichever is applicable.
7. For exhibitors using their own fitting, please note that each light fitting is considered a connection
8. All electrical connection to equipment must be tested and approved by the Organizer's appointed licensed engineer prior to the turning on of the power supply. The Organizer reserves the right to terminate the power supply to any installation which are found to be dangerous or may cause any disruption to the power supply.

**Indemnity Clause:**

All risks associated with goods & services supplied by the Company in the Contract shall, unless expressly agreed by the Company in writing, pass to the Exhibitor on delivery or installation. The Company is under no liability for personal injury to the Exhibitor or its servants, agents, invitees or licensees no matter how they are caused save that this exclusion of liability shall not apply if caused by the negligence of the Company. The Company is under no liability for the loss of or damage to exhibits or to property owned by the Exhibitor, its servants, agents, invitees, or licensees no matter how it is caused. The indemnity provided under this clause shall survive the termination of this contract and is in addition to any other remedy which the Company is entitled to under the law.

**PLEASE NOTE:**

- (1) Exhibitors will be held responsible for any losses or damages to furniture or fittings.
- (2) Orders are valid only when accompanied by full remittance. Payment could be made by Singapore local cheque, bank draft or telegraphic transfer.
- (3) Late orders i.e. received after the deadline may not be catered to, and if available, will be subjected to a **30% surcharge**. On-site orders may not be provided and, if available, will be subjected to a 50% surcharge. Priority will be given to advance orders.
- (4) Full cost shall apply for cancellation received two weeks before the event. Orders without remittances will not be entertained.
- (5) Amounts paid are non-refundable should the event be cancelled or withdrawn.
- (6) An invoice will be issued to you upon receiving the order form and payment details will be instructed.
