Prior to UNDP, he was part of the U.S. Agency for International Development (USAID)'s team that managed the U.S. contribution to the global HIV response, from Washington, DC (1997-2005) and then as an Asia regional position in Bangkok, Thailand (2005-2010). Over 22 years, his work has taken him to countries throughout Asia, the Pacific, Africa, Latin America, the Caribbean, Central Asia, and Europe. Hiker Chiu, a pioneer in the Asian region for intersex human rights, hails from Taiwan and founded OII-Chinese in 2008. OII-Chinese serves as the first platform for Chinese-speaking intersex individuals to advocate for their rights. Hiker Chiu made history in Taiwan by publicly coming out as an intersex person and spearheading the "Global Free Hugs with Intersex Movement" in 2010. Since 2013, Hiker has dedicated their efforts to fostering intersex connections in Asia, which became the foundation for "Intersex Asia," the first and only regional network of intersex organizations in Asia, established in 2018. Currently, Hiker holds the Chair and Executive Director position for Intersex Asia. In addition, Hiker served as an advisor for the Intersex Human Rights Fund since 2015, representing the Asian region. That same year, Hiker was elected as the co-chair of ILGA Asia, serving from 2015 to 2017.
