Naveed Akbar is Director General for the National Socio-Economic Registry (NSER) and Conditional Cash Transfer (CCT) Programs at BISP. He has spearheaded Pakistan's first digital socio-economic census covering over 35 million households of the country and established the NSER. He has designed and implemented successful health- and nutrition- and education-focused CCTs across Pakistan. Naveed has also designed and implemented several targeted subsidies and shock-response initiatives for poor and ultra-poor segments of the country, including noteworthy emergency cash assistance during COVID-19 and response to recent monsoon floods in Pakistan.
