National road safety council^{RAST}

- The working office of the council was established under the Ministry of Road and Transport Development.
- The council is convened no less than once a year.
- Main role of the council:
 - Develop policy and program on road safety;
 - Issue a recommendation on improving road safety;
 - Research with relevant bodies;
 - Monitor implementation progress of road safety policy and program objectives;
 - Review operation of relevant stakeholders;
 - Review and discuss annual report;
 - Developing cooperation with other countries and international development organizations on ensuring road safety;
 - Organizing conference, workshops and training and promoting road safety.

깆 National Road Safety Program

- Based on UN Road safety Decade of Action, CAREC Regional Road Safety Strategy, UN SDG and recommendation of TA
- Developed by the National Road Safety Council, with cross-departmental collaboration (developed with relevant stakeholders' input)
- Approved in 2019; to be implemented from 2019 to 2023. Reduce number of traffic accidents by 50%,
 - 1. Reduce risk and social cost of traffic accidents by 50%,
 - 2. Develop and expand road transport logistic network that will support economic growth, meet the demand and offer safe and comfortable service by 30%,
 - 3. 50% of all roads of Ulaanbaatar city, urban areas, provincial centers and state roads to be fitted with surveillance camera to improve safety of citizens and to prevent crimes.

Coordination and collaboration

- National Road Safety Council coordinate road safety actions like awareness campaigns.
 - Campaigns are accompanied by police enforcement activities
- All ministries and departments coordinate to achieve National Road Safety Program
- Transport Police Department collects data on road crashes in the database of the National Police Agency
 - Road safety data is shared when requested. The data is not publicly available.
 - Informal cross-checking between Police and Health is conducted
 - Transport Police Department is planning to improve road crash data management
- The council is planning to establish <u>integrated road safety information</u> <u>database</u>
 - Will improve collection and management of road safety related data (police, health, insurance, technical inspection, car maintenance etc.)
 - Challenge with budget for system and server



Some considerations to improve road safety management

- Coordination is key
- Joint road safety plans
- Reliable crash data, and sharing of data
- Stakeholder engagement
- Capacity Development
- Collaborating with private entities to ensure/regulate road safety on non-public/private/mining road
