- 2. The Museum Shop accepts only Philippine ₱ cash payments.

Museum Guidelines (excerpt)

To ensure that museum visitors have a safe and enjoyable experience, the National Museum of the Philippines requires all visitors' compliance with the following rules and guidelines:

- 1. All visitors and items are subject to security inspection.
- 2. Prohibited items must be deposited at the bag counter prior to admission.
- 3. The National Museum reserves the right to refuse admission of persons and items that may threaten the security of visitors, staff, and collections.
- 4. **Photography**. Taking of pictures is allowed inside the museum premises. However, the use of camera flash is strictly prohibited.
- 5. **Prohibited items A**. These items are NOT allowed inside the museum premises and NOT allowed for baggage check-in:
 - Firearms, explosives, firecrackers
 - Wrapped packages or gifts
 - Pets
- 6. **Prohibited items B**. These items are NOT permitted inside the museum buildings and subject for baggage check-in:
 - Bags, luggage, and items larger than 33 x 43 cm (13 x 17 in)
 - Mobile/electronic luggage
 - Backpacks bigger than 27.94 x 22 cm (11 x 9 in)
 - · Food and beverage
 - Disposable water bottles

- Video cameras, selfie sticks, and tripods
- Art materials and toys
- Plant, flowers, and organic materials

7. Prohibited conduct

- Touching of exhibition items such as paintings, sculptures, artifacts, specimens, and other objects on display
- Destroying, damaging, or removing property.
- · Opening of windows and window shades.
- Leaning on glass showcases and pedestals, and stepping on the exhibition platforms.
- Placing any items such as cellphones, cameras, and bags on the exhibition items and pedestals.
- Carrying of firearms, other dangerous or deadly weapons, or explosives.
- Displaying or carrying placards, signs, or banners.
- Loitering, sleeping, or participating in unwarranted assemblies.
- · Performing obscene or indecent acts.
- · Engaging in disorderly conduct.
- Using loud, abusive, or otherwise improper language.
- Shouting.
- Sitting and lying on floors.
- Using, possessing, or selling illegal drugs.
- Smoking.
- 8. Decorum
 - Observe proper decorum at all times.
 - Avoid physical activity that may harm the collections.
 - Staircases must be free from any obstruction at all times.
 - Keep noise levels to a minimum when inside the galleries.
