Research Director Economic Policy Research Institute (EPRI)

Michael Samson is the Research Director of the Economic Policy Research Institute (EPRI), a global research institute with offices in Bangkok, Cape Town, and San Juan. He has 36 years of experience working in social protection, and specializes in designing, implementing, monitoring and evaluating integrated social protection programs, policies, and systems; and his project experience in these areas includes work in 58 countries in Africa, Latin America, Eastern Europe, Asia and the Pacific as well as many related publications. He has conducted integrated social protection and public finance reviews in Cambodia, Indonesia and the Kyrgyz Republic.

He led the international team supporting the evaluation of Thailand's Child Support Grant, designed a longterm social protection training-of-trainer capacity development program in Viet Nam, and supported 32 other social protection policy and program-related projects over the past 15 years in Asia and the Pacific. His current work explores the role of social protection as the vital social dimension of integrated climate, development, and equity strategies. He is also on the economics faculty at the Williams College Center for Development Economics in the United States, and he has a Ph.D. in Economics from Stanford University.
