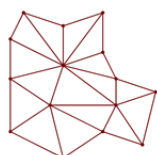

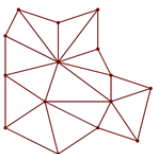
Delegates

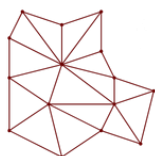

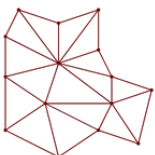

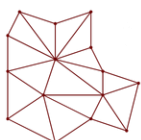

Terms & Conditions

Acceptance and Allocation:

Energy & Resources Law Association (ER Law) and the Conference Organiser, All Occasions Management (Conference Organiser), reserve the right to accept or reject any application for partnership at their absolute discretion, with the return of any deposit paid. Partnership and exhibition packages are allocated on a first-come, first-served basis and are generally assigned to organisations who apply earliest. Allocation of packages remains at the discretion of ER Law and the Conference Organiser, whose decision will be final.

Application and Payment:

To confirm a partnership or exhibition package, please complete the application form and return it to sponsorship@aomevents.com. A signed Partnership Agreement and 50% deposit are required to confirm participation. A tax invoice and confirmation letter outlining partnership details will then be issued. Full payment must be made within seven days of the invoice date, with the remaining balance due no later than 60 days prior to the conference. Partnership entitlements and benefits will not commence or be allocated until payment has been received in full. All prices are quoted in Australian Dollars and are inclusive of GST. Payments may be made via bank transfer or credit card.

Cancellation Policy:

If the event is cancelled by ER Law and/or Conference Organiser less than 12 months prior to the scheduled date, the Sponsor is entitled to a full refund. If the event is rescheduled and the Sponsor can reasonably demonstrate an inability to participate, a full refund will also apply. In the case of Sponsor cancellation, notification must be provided in writing to the Conference Manager. Cancellations received more than 60 days prior to the conference will receive a full refund less a \$500 administration fee. Cancellations received between 30 and 60 days prior to the conference will receive a 50% refund. No refunds will be provided for cancellations received less than 30 days prior to the conference. Delegate substitutions may be made at any time. ER Law reserves the right to retain monies paid unless the partnership is resold.

Consequential Damage:

ER Law and the Conference Organiser will not be liable for any indirect or consequential damages arising out of a breach of the Exhibition/Partnership contract.
