

TERMS AND CONDITIONS

Updated as of 15 July 2024

GENERAL

1. Tour de France Prudential Singapore Criterium 2024 (the "Event") is co-owned and, organised and managed by Evoke EXP Pte Ltd (the "Event Owner", "Event Organiser"). These Terms and Conditions (the "T&Cs"), which can be found at <https://singaporecriterium.com/> (the "Official Website"), apply to all persons participating in the Event. Further details on the event and race categories rules and regulations will be published on <https://singaporecriterium.com/> (the "Official Website").
2. By submitting the application to participate in the Event, the person named in the online application form (the "Participant") acknowledges that he/she has read these Terms and Conditions, and confirms his/her agreement and acceptance to abide by and comply with these Terms and Conditions. The Event Owner and the Event Organiser reserve the right to vary, amend, delete or add to any of these Terms and Conditions, at any time, in its sole and absolute discretion without prior notice.
3. By submitting the application, the Participant gives the Event Owner, the Event Organiser and their relevant business partners and agents permission to collect, use, disclose and process the Participant's personal data for purposes reasonably required for the organising and conducting of the Event; to contact the Participant to promote and market the Event and future events and its authorised service providers; for the purposes contemplated in these Terms and Conditions and to promote and market the Event and future events organised or held by the Event Owner and/or Event Organiser; other reasonable purposes as set out in the Data Protection Policy, which is accessible [here](#) which the Participant is deemed to have read and understood through his/her submission of the application. Personal data shall have the meaning as defined in the Personal Data Protection Act 2012.
4. Registration for the Event is confirmed only upon issuance of a confirmation email by the Event Organiser. Registration is strictly non-transferrable.
5. The Event Owner and the Event Organiser reserve the right to use any photographs, videos, motion pictures, images, recordings, or any other recording of the Event and its Participants for any commercial advertising and other promotional purposes linked to the Event or future events organised or held by the Event Owner and Event Organiser ("Promotional Purposes"), subject to compliance with the Personal Data Protection Act 2012. By submitting the application, the Participant gives his/her consent to the Event Owner and Event Organiser to collect, use and disclose his/her personal data in photographs, videos, motion pictures, images, recordings, or any other recording of the Event for the Promotional Purposes. The Participant has the right to withdraw his/her consent at any time upon giving reasonable notice to TDFSG@evokeexp.com.
6. The Participant agrees to: provide true, accurate, current and complete information about himself/herself in the registration form (the "Registration Data") and maintain and promptly update the Registration Data to ensure that it remains true, accurate, current and complete. The Event Owner and/or the Event Organiser may contact the Participant from time to time by email and/or SMS and/or phone call in connection with the Event.
7. If there is ambiguity in any of these provisions, the Event Organiser shall be the sole authority to interpret them – and in so doing, they may (but is not obliged to) take into account the interests of all affected Participants. Participants will be notified of any amendments to these Terms and Conditions on the Official Website, and their continued participation in the Event

shall be deemed as the Participants' acceptance and agreement to any revised Terms and Conditions.

8. Any requirements to be fully covid vaccinated and to provide valid documentation to certify medical ineligibility shall be construed in accordance with the guidelines issued by the Singapore Government in force at the time of the Event. The Event Organiser reserve the right to implement safe management measures as required and/or as may be determined necessary to ensure the safety of the participants and event staff. The Event Organiser reserves the right to deny entry, disqualify or remove any Participant from the event venue who do not comply to the measures.
9. To the greatest extent permitted by the law, the Event Owner and Event Organiser shall not be held liable to the Participant or any third party for any loss, damage, personal injury, death, or damage to or loss of property, in connection with the Event. Any participation in the Event, and/or any of the activities or events contained or occurring therein, are at the sole risk of the Participant.
10. The Event Organiser reserve the right to cancel or change any details of the Event or any component at any time without prior notice to Participants. Every reasonable effort will be made to inform Participants of changes prior to the date and/or timing of the Event. The Event Owner and the Event Organiser shall not be liable for any indirect and/or consequential loss or inconvenience arising from any cancellation or change of any details of the Event or any component thereof.
11. Event Owner has the sole and absolute discretion to exclude any Participants from participating in the Event without any obligation to furnish notice and/or reason and reserves the right to disqualify or disregard any Participant who does not comply with the Terms and Conditions.
12. The Event Owner may at any time at its absolute discretion, without prior notice or assigning any reason thereof or being liable to any person, (i) suspend, cancel or terminate the Event, or (ii) delete, vary, supplement, amend, modify any one or more of the terms and conditions of the Event. Event Owner's determination of all matters in connection with the Event shall be final, binding and conclusive. The Event Owner is not obliged to give any reason or prior notice on any matter concerning the Event. No appeal, correspondence or claims will be entertained. The Event Owner has the right and discretion to determine whether a party has met the requirements to participate in the Event. Participants shall not be entitled to any damages or compensation whatsoever or howsoever arising as a result of such amendment, suspension or termination.
13. By participating in the Event, all Participants agree and undertake to, at all times, indemnify, keep indemnified, and hold the Event Owner, its employees and agents harmless against all losses (including direct, indirect, incidental and/or consequential losses), damages (including general, special, and/or punitive damages), demands, injuries (other than personal injury caused by Evoke's and Prudential's negligence), claims, costs, penalties, interest and fees (including all legal fees as between solicitor and client or otherwise on a full indemnity basis whether or not incurred in respect of any real, anticipated, or threatened legal proceedings), howsoever caused by, arising or resulting from, whether directly or indirectly, their participation in the Event, and/or any breach or purported breach of these Terms and Conditions and/or any applicable law.
14. Any trademarks, graphic symbols, logos or intellectual property contained in any materials used in connection with this Event, are the property of their respective owners.

15. Failure by the Event Owner to exercise any of its right or remedy under these Terms and Conditions does not constitute a waiver of that right or remedy.
16. The Terms and Conditions shall be governed by Singapore law and the Participants agree to submit to the exclusive jurisdiction of the courts of Singapore.
17. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Right of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.

EVENT CATEGORIES

18. Participants can sign up for the following Event categories if they meet the following criteria for each category:
 - a) PRURide Seeker's Mixed Novice Criterium
 - i. Age 19 years and above (as of the event year)
 - ii. Have little or no prior cycling race experience
 - b) PRURide Seeker's Mixed Open Criterium
 - i. Age 19 years and above (as of the event year)
 - ii. Have prior cycling race experience
19. Where applicable, Participants are strictly not allowed to do the following after they have completed their registration:
 - a) Transfer or sell their registration slots/event bibs;
 - b) Change their event categories/activities
20. The following applies to PRURide Seeker's Mixed Novice Criterium:
 - a) Registration for PRURide Seeker's Mixed Novice Criterium is from 9 July 2024, 11:00am to 22 July 2024, 11:59pm.
 - b) If the Participant is under the age of 21, he/she will need his/ her parent's or guardian's consent and complete the indemnity section found in the online registration form. The completion of the indemnity form found in the online registration form shall constitute and be deemed as the Participant (who is under the age of 21) having obtained consent from his/her parent or legal guardian to participate in the Event, and accordingly, the parent's and/or legal guardian's (i) consent and approval for the Participant to participate in the Event, and (ii) acknowledgement and confirmation that the parent and/or legal guardian has read, understood and agreed to these Regulations.
 - c) A minimum of 20 riders is required in order to proceed with the race. Participants will be informed should the race be cancelled.
 - d) After registration for PRURide Seeker's Novice Criterium has been completed, participants must fulfil the requirements of the event in order to be eligible to take part in the race.
 - e) To be eligible to take part in the race, participants must:
 - i. Complete one (1) class in the PRURide Novice Race-Ready Program; and
 - ii. Qualify as the fastest 140 participants in the Qualifying Race held on 8 September 2024.

- f) There will be two (2) races held for this category, Mixed Novice Criterium Race 1 and Race 2. Participants will be allocated to their respective races by the based on their qualifying time. The allocation of participants in the races will be done by the Event Organiser, whom will make the final decision on the allocation. Switching of races will not be allowed.
- g) The PRURide Seeker's Mixed Novice Criterium races will be held on 10 November 2024 as part of Tour de France Prudential Singapore Criterium 2024. A mandatory pre-race briefing will be conducted on 6 November 2024. A race technical guide will also be shared closer to the event weekend.
- h) Participants are advised to reach the race venue at least 45 minutes before the allocated race slot. The reporting time will be advised to all participants during the mandatory pre-race briefing. Participants will not be allowed to participate in the race if they are late.
- i) Format of the race:
 - i. Participants of PRURide Seeker's Mixed Novice Criterium will require **either of** the following in order to participate in the race:
 - 1. A SCF Day-Race Licence from Singapore Cycling Federation (SCF). Purchase can be made through SCF's website [here](#).
 - 2. Opt-in for the complimentary personal accident insurance (issued by Prudential) during the registration for the race.
 - ii. For riders participating in the Mixed Novice Criterium race, no SCF General Classification (GC) ranking points will be accorded.
 - iii. Riders will ride several laps around a closed circuit. A bell is rung to announce to the riders that whoever wins the next lap, wins the race.
 - iv. Top three (3) winners will be awarded for Mixed Novice Criterium Race 1.
 - v. Top three (3) winners will be awarded for Mixed Novice Criterium Race 2.
 - vi. Further race details will be announced during the mandatory pre-race briefing.

21. The following applies to PRURide Seeker's Mixed Open Criterium:

- a) Registration for PRURide Seeker's Mixed Open Criterium is from 9 July 2024, 11:00am to 22 July 2024, 11:59pm.
- b) If the Participant is under the age of 21, he/ she will need his/ her parent's or guardian's consent and complete the indemnity section found in the online registration form. The completion of the indemnity form found in the online registration form shall constitute and be deemed as the Participant (who is under the age of 21) having obtained consent from his/her parent or legal guardian to participate in the Event, and accordingly, the parent's and/or legal guardian's (i) consent and approval for the Participant to participate in the Event, and (ii) acknowledgement and confirmation that the parent and/or legal guardian has read, understood and agreed to these Regulations.
- c) A minimum of 20 riders is required in order to proceed with the race. Participants will be informed should the race be cancelled.
- d) The PRURide Seeker's Mixed Novice Criterium races will be held on 10 November 2024 as part of Tour de France Prudential Singapore Criterium 2024. A mandatory pre-

race briefing will be conducted on 6 November 2024. A race technical guide will also be shared closer to the event weekend.

- e) Participants are advised to reach the race venue at least 45 minutes before the allocated race slot. The reporting time will be advised to all participants during the mandatory pre-race briefing. Participants will not be allowed to participate in the race if they are late.
- f) Format of a race:
 - i. Participants of PRURide Seeker's Mixed Open Criterium will require either of the following in order to participate in the race:
 - 1. A SCF Day-Race Licence from Singapore Cycling Federation (SCF). Purchase can be made through SCF's website [here](#).
 - 2. Opt-in for the complimentary personal accident insurance (issued by Prudential) during the registration for the race.
 - 3. Valid UCI License. UCI License can be purchase [here](#).
 - ii. For riders participating in the Mixed Open Criterium race, they are eligible to accumulate SCF General Classification (GC) ranking points from the race. Please note that in order to accumulate GC ranking points, the Participant must hold a valid UCI Licence. Participants without a valid UCI Licence will not be eligible for any GC ranking points, regardless of their eventual position after the race.
 - iii. Riders will ride several laps around a closed circuit. A bell is rung to announce to the riders that whoever wins the next lap, wins the race.
 - iv. Top three (3) winners will be awarded for Mixed Open Criterium Race.
 - v. Further race details will be announced during the mandatory pre-race briefing.

SAFETY AND MEDICAL

- 22. The Event Organiser reserves the right, at any time and without prior notice to Participants, to amend the cycling routes for the Event as it deems fit for the safety of the Participants. The Event Organiser and Event Owner shall not be liable for any loss or inconvenience resulting from or attributable to such changes.
- 23. Participants must not:
 - a) Ride without a cycling helmet;
 - b) Ride dangerously or negligently;
 - c) Wear any mobile music device while riding;
 - d) Use hand-held cameras or telephones while riding; or
 - e) Ride pillion with another person or their pets
- 24. For the safety of Participants, only standard road racing bicycles will be allowed. The following bicycle and/or equipment are not allowed for all PRURide Seeker's Criterium and here are some examples. The full equipment list will be reflected in the race technical guide:
 - a) Bicycles with disc wheels and/or disc wheel covers;
 - b) Wheels with less than 12 spokes
 - c) Bicycles with aero or extension bars;
 - d) Bicycles with fixed wheels or fixed gears;
 - e) Specialist time trial bicycles;

- f) Aero helmets;
 - g) External attachments such as saddlebags, bento boxes, rear/stem mounted bottle cage etc.
 - h) Bento Boxes;
 - i) Bicycle Lights;
 - j) Electric/power-assisted bicycles
25. Participants who attend the Event with bicycles not on the list and/or bicycles not in a safe working condition will be prohibited from participating in the Event.
26. All bicycles, regardless of the categories, must be properly fitted with two functioning brakes.
27. All Participants must follow the designated routes and abide by the instructions given by the security, traffic management team and Event officials throughout the Event.
28. For safety reason, event officials may remove Participants from the track that are deemed riding in a manner that may risk safety of other Participants.
29. Participants not wearing the Event bib will not be allowed to participate in the Event.
30. For safety reasons, Participants have to be equipped with proper footwear. Participants are not allowed to be in slippers, sandals, foam clogs and other footwear deemed unsuitable by the Event Organiser during their ride.
31. Participants are encouraged to consult their medical practitioners before participating in the Event.
32. If there is an emergency, medical personnel reserve the right:
- a) to remove any Participants if they decide that he/she is unable to continue his/her ride;
 - and
 - b) to send any casualties to the nearest hospital.
33. The Event Organiser reserve the right to deny entry, disqualify or remove any Participant from the Event venue who do not comply to the Event's Terms and Conditions.
