

# TERMS AND CONDITIONS

Updated as of 9 July 2024

## GENERAL

1. PRURide Seeker's Society Race-Ready Program (the "Event") is owned by Prudential Assurance Company Singapore Pte Ltd (the "Event Owner") and organised and managed by PICH Event Management Pte Ltd (the "Event Organiser"). These Terms and Conditions (the "T&Cs"), which can be found at <https://www.miceneurol.com/prudential-tdf> (the "Official Website"), apply to all persons participating in the Event. Further details on the event will be published on <https://www.miceneurol.com/prudential-tdf> (the "Official Website").
2. By submitting the application to participate in the Event, the person named in the online application form (the "Participant") acknowledges that he/she has read these Terms and Conditions, and confirms his/her agreement and acceptance to abide by and comply with these Terms and Conditions. The Event Owner and the Event Organiser reserve the right to vary, amend, delete or add to any of these Terms and Conditions, at any time, in its sole and absolute discretion without prior notice.
3. By submitting the application, the Participant gives the Event Owner, the Event Organiser and their relevant business partners and agents permission to collect, use, disclose and process the Participant's personal data for purposes reasonably required for the organising and conducting of the Event; to contact the Participant to promote and market the Event and future events and its authorised service providers; for the purposes contemplated in these Terms and Conditions and to promote and market the Event and future events organised or held by the Event Owner and/or Event Organiser; other reasonable purposes as set out in the Data Protection Policy, which is accessible [here](#) which the Participant is deemed to have read and understood through his/her submission of the application.
4. Registration for the Event is confirmed only upon issuance of a confirmation email by the Event Organiser. Registration is strictly non-transferrable.
5. The Event Owner and the Event Organiser reserve the right to use any photographs, videos, motion pictures, images, recordings, or any other recording of the Event and its Participants for any commercial advertising and other promotional purposes linked to the Event or future events organised or held by the Event Owner and Event Organiser ("Promotional Purposes"), subject to compliance with the Personal Data Protection Act 2012. By submitting the application, the Participant gives his/her consent to the Event Owner and Event Organiser to collect, use and disclose his/her personal data in photographs, videos, motion pictures, images, recordings, or any other recording of the Event for the Promotional Purposes. The Participant has the right to withdraw his/her consent at any time upon giving reasonable notice to [prudential@miceneurol.com](mailto:prudential@miceneurol.com).
6. The Participant agrees to: provide true, accurate, current and complete information about himself/herself in the registration form (the "Registration Data") and maintain and promptly update the Registration Data to ensure that it remains true, accurate, current and complete. The Event Owner and/or the Event Organiser may contact the Participant from time to time by email and/or SMS and/or phone call in connection with the Event.
7. If there is ambiguity in any of these provisions, the Event Organiser shall be the sole authority to interpret them – and in so doing, they may (but is not obliged to) take into account the interests of all affected Participants. Participants will be notified of any amendments to these Terms and Conditions on the Official Website, and their continued participation in the Event

shall be deemed as the Participants' acceptance and agreement to any revised Terms and Conditions.

8. Any requirements to be fully covid vaccinated and to provide valid documentation to certify medical ineligibility shall be construed in accordance with the guidelines issued by the Singapore Government in force at the time of the Event. The Event Organiser reserve the right to implement safe management measures as required and/or as may be determined necessary to ensure the safety of the participants and event staff. The Event Organiser reserves the right to deny entry, disqualify or remove any Participant from the event venue who do not comply to the measures.
9. To the greatest extent permitted by the law, the Event Owner and Event Organiser shall not be held liable to the Participant or any third party for any loss, damage, personal injury, death, or damage to or loss of property, in connection with the Event. Any participation in the Event, and/or any of the activities or events contained or occurring therein, are at the sole risk of the Participant.
10. The Event Organiser reserve the right to cancel or change any details of the Event or any component at any time without prior notice to Participants. Every reasonable effort will be made to inform Participants of changes prior to the date and/or timing of the Event. The Event Owner and the Event Organiser shall not be liable for any indirect and/or consequential loss or inconvenience arising from any cancellation or change of any details of the Event or any component thereof.
11. Event Owner has the sole and absolute discretion to exclude any Participants from participating in the Event without any obligation to furnish notice and/or reason and reserves the right to disqualify or disregard any Participant who does not comply with the Terms and Conditions.
12. The Event Owner may at any time at its absolute discretion, without prior notice or assigning any reason thereof or being liable to any person, (i) suspend, cancel or terminate the Event, or (ii) delete, vary, supplement, amend, modify any one or more of the terms and conditions of the Event. Event Owner's determination of all matters in connection with the Event shall be final, binding and conclusive. The Event Owner is not obliged to give any reason or prior notice on any matter concerning the Event. No appeal, correspondence or claims will be entertained. The Event Owner has the right and discretion to determine whether a party has met the requirements to participate in the Event. Participants shall not be entitled to any damages or compensation whatsoever or howsoever arising as a result of such amendment, suspension or termination.
13. By participating in the Event, all Participants agree and undertake to, at all times, indemnify, keep indemnified, and hold the Event Owner, its employees and agents harmless against all losses (including direct, indirect, incidental and/or consequential losses), damages (including general, special, and/or punitive damages), demands, injuries (other than personal injury caused by Prudential's negligence), claims, costs, penalties, interest and fees (including all legal fees as between solicitor and client or otherwise on a full indemnity basis whether or not incurred in respect of any real, anticipated, or threatened legal proceedings), howsoever caused by, arising or resulting from, whether directly or indirectly, their participation in the Event, and/or any breach or purported breach of these Terms and Conditions and/or any applicable law.
14. Any trademarks, graphic symbols, logos or intellectual property contained in any materials used in connection with this Event, are the property of their respective owners.

15. Failure by the Event Owner to exercise any of its right or remedy under these Terms and Conditions does not constitute a waiver of that right or remedy.
16. The Terms and Conditions shall be governed by Singapore law and the Participants agree to submit to the exclusive jurisdiction of the courts of Singapore.
17. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Right of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.

## **EVENT CATEGORIES**

18. The Event serves as a criterion to entry to the Tour de France Prudential Criterium Singapore – PRURide Seeker's Criterium Race. Participants must complete the requirements in order to be eligible for PRURide Seeker's Criterium Race.
19. Participants can sign up for the following Event categories if they meet the following criteria for each category:
  - a) PRURide Novice Race-Ready Program
    - i. Age 19 years and above (as of the event year)
    - ii. Have little or no prior cycling race experience
  - b) PRURide Seasoned Race-Ready Program
    - i. Age 19 years and above (as of the event year)
    - ii. Have prior cycling race experience
20. Where applicable, Participants are strictly not allowed to do the following after they have completed their registration:
  - a) Transfer or sell their registration slots/event bibs;
  - b) Change their event categories/activities
21. The following applies to PRURide Novice Race-Ready Program:
  - a) Registration for PRURide Novice Race-Ready Program is from 9 July 2024, 11:00am to 22 July 2024, 11:59pm.
  - b) If the Participant is under the age of 21 years old, he/ she will need his/ her parent's or guardian's consent and complete the indemnity section found in the online registration form. The completion of the indemnity form found in the online registration form shall constitute and be deemed as the Participant (who is under the age of 21) having obtained consent from his/her parent or legal guardian to participate in the Event, and accordingly, the parent's and/or legal guardian's (i) consent and approval for the Participant to participate in the Event, and (ii) acknowledgement and confirmation that the parent and/or legal guardian has read, understood and agreed to these Regulations.
  - c) Participants must complete any one (1) session of Technical Class by SCF or Mobility and Strength for Cyclist by UFIT or Virtual Cycling Class by SCF and qualify as the fastest 140 participants in the Novice Qualifying Race to be eligible to participate in PRURide Seeker's Mixed Novice Criterium Race.

- i. Technical Class by SCF
  1. Each clinic will be a 4-hour session consisting of a theory lesson and practical session with bicycles.
  2. Only road bikes are allowed. 'Aero' wheels, 'disk' wheels and 'aero' extension bars are not allowed
  3. For safety purposes, the Event Organiser reserves the right to deny participation if a participant shows up without appropriate cycling helmet, shoes and bicycle.
  4. Slots are available on a first-come-first-serve basis.
  5. Participants who missed the registered Technical class slot will not be allowed to join in the next slot.
  6. Non-registered guests are not allowed to participate.
  
- ii. Mobility and Strength for Cyclist by UFIT
  1. Slots are available on a first-come-first-serve basis.
  2. Participants who missed the registered UFIT Training slot, will not be allowed to join in the next slot.
  3. Non-registered guests are not allowed to participate.
  4. This activity is organised and delivered by UFIT Singapore. [Click here](#) to view the full terms and conditions.
  
- iii. Virtual Cycling Class by SCF
  1. Slots are available on a first-come-first-serve basis.
  2. Zwift programme is used for the purpose of this class, and this will be provided for by the venue. Participants who would like to use their own Zwift account for their session will need to join the Zwift session link at least 24 hours before their session. More instructions will be provided alongside the email.
  3. Only LOOK Cleats, Shimano SPD Cleats and Shimano SPD-SL (YELLOW only) are compatible with the studio's Wattbikes. Alternatively, you may opt for a pedal cage or bring your own pedals for the Virtual Cycling Classes.
  4. Participants who missed the registered Virtual Cycling Class slot will not be allowed to join in the next slot.
  5. Non-registered guests are not allowed to participate.
  6. This activity is organised and delivered by Singapore Cycling Federation. [Click here](#) to view the full terms and conditions.
  
- iv. Novice Qualifying Race:
  1. Participant who did not attend the Technical Class or Mobility Training Class or Virtual Cycling Class will not be eligible to participate in the Novice Qualifying Race.
  2. Only road bikes are allowed. 'Aero' wheels, 'disk' wheels and 'aero' extension bars are not allowed
  3. For safety purposes, the Event Organiser reserves the right to deny participation if a participant shows up without appropriate cycling helmet, shoes and bicycle.
  4. Participants of the Novice Qualifying Race will ride for three (3) laps around the track.
  5. Qualify as the fastest 140 participants in the Novice Qualifying Race to be eligible to participate in the PRURide Seeker's Mixed Novice Criterium.

6. The fastest 140 participants will automatically be registered for the PRURide Seeker's Mixed Novice Criterium with the same information that was submitted for registration.
7. Participants who missed the allocated Novice Qualifying Race slot, will not be allowed to join in the next slot.
8. In the event a Novice Qualifying Race slot is cancelled due to inclement weather conditions, a replacement slot will be provided. Instructions will be provided by the Event Owner and/or Event Organiser.

22. The following applies to PRURide Seasoned Race-Ready Program

- a) Registration for PRURide Seasoned Race-Ready Program is from 9 July 2024, 11:00am to 22 July 2024, 11:59pm.
- b) If the Participant is under the age of 21 years old, he/ she will need his/ her parent's or guardian's consent and complete the indemnity section found in the online registration form. The completion of the indemnity form found in the online registration form shall constitute and be deemed as the Participant (who is under the age of 21) having obtained consent from his/her parent or legal guardian to participate in the Event, and accordingly, the parent's and/or legal guardian's (i) consent and approval for the Participant to participate in the Event, and (ii) acknowledgement and confirmation that the parent and/or legal guardian has read, understood and agreed to these Regulations.
- c) Participants who successfully registered for PRURide Seasoned Race-Ready Program will be automatically registered for the PRURide Seeker's Mixed Open Criterium. Registration for the Event is confirmed only upon issuance of a confirmation email by the Event Organiser.
- d) Participants of the PRURide Seeker's Society Race Preparation Programme (Seasoned) can choose to opt in for the Mobility Training Classes or the Virtual Cycling Classes. Participation of these classes are optional and does not serve as a criteria to participate in the PRURide Seeker's Mixed Open Criterium.
  - i. Mobility and Strength for Cyclist by UFIT
    1. Slots are available on a first-come-first-serve basis.
    2. Participants who missed the registered UFIT Training slot, will not be allowed to join in the next slot.
    3. Non-registered guests are not allowed to participate.
    4. This activity is organised and delivered by UFIT Singapore. [Click here](#) to view the full terms and conditions.
  - ii. Virtual Cycling Class by SCF
    1. Slots are available on a first-come-first-serve basis.
    2. Zwift programme is used for the purpose of this class, and this will be provided for by the venue. Participants who would like to use their own Zwift account for their session will need to join the Zwift session link at least 24 hours before their session. More instructions will be provided alongside the email.

## **SAFETY AND MEDICAL**

23. The Event Organiser reserves the right, at any time and without prior notice to Participants, to amend the cycling routes for the Event as it deems fit for the safety of the Participants. The Event Organiser and Event Owner shall not be liable for any loss or inconvenience resulting from or attributable to such changes.
24. Participants must not:
  - a) Ride without a cycling helmet;
  - b) Ride dangerously or negligently;
  - c) Wear any mobile music device while riding;
  - d) Use hand-held cameras or telephones while riding; or
  - e) Ride pillion with another person or their pets
25. For the safety of Participants, only the following bicycles will be allowed for all PRURide Seeker's Society Cycling Clinic and Race Simulation:
  - a) Road bicycles.
  - b) No 'aero' or 'disk' wheels.
  - c) No 'aero' extension bars.
26. All bicycles, regardless of the categories, must be properly fitted with two functioning brakes.
27. All Participants must follow the designated routes and abide by the instructions given by Event officials throughout the Event.
28. For safety reason, event officials may remove Participants from the event that are deemed behaving in a manner that may risk safety of other Participants.
29. For safety reasons, Participants have to be equipped with proper footwear. Participants are not allowed to be in slippers, sandals, foam clogs and other footwear deemed unsuitable by the Event Organiser during their ride.
30. Participants are encouraged to consult their medical practitioners before participating in the Event.
31. If there is an emergency, medical personnel reserve the right:
  - a) to remove any Participants if they decide that he/she is unable to continue his/her ride; and
  - b) to send any casualties to the nearest hospital.
32. The Event Organiser reserve the right to deny entry, disqualify or remove any Participant from the Event venue who do not comply to the Event's Terms and Conditions.
