

# 7th National Catholic School Improvement Colloquium Terms & Conditions

The Australian Goods and Services Tax (GST) is applicable to all goods and services offered by Catholic Education South Australia (CESA) and all prices are inclusive of the GST. Furthermore, all rates are payable in Australian Dollars (AUD\$).

## Registration inclusions:

- Entrance to the Mass on Sunday 11 October
- Full 2 day conference attendance
- Morning tea, lunch and afternoon tea on both conference days
- Entry to welcome drinks function
- Name badge

## Registration payment:

All payments will be made to CESA (the host of the 7th National Catholic School Improvement Colloquium).

### *Payment Options:*

1. Credit/Debit Card:
  - a. The preferred payment method is credit/debit card. Accepted credit/debit cards are Visa and MasterCard. Please note all transactions will appear on your statement as CESA 7NCSIC 2026.
  - b. Credit card surcharge of 1.9% applies to all credit or debit card payments.
2. EFT payment:
  - a. EFT payments will not be available for the 7th National Catholic School Improvement Colloquium except under exceptional circumstances.

### *Acknowledgements:*

Your registration and payment will be acknowledged via email with confirmation of your requirements according to your registration form. Your registration will not be processed or confirmed if payment does not accompany your form (unless an alternative payment method has been arranged as per point 3 above. In these cases registration will be “reserved” but only until the due date of the invoice).

### *Unpaid registrations:*

In order to receive Early Bird rates, payment must be received by 31 May 2026. If payment has not been received before 1 June 2026, early bird registration will be updated to standard registration and a new invoice will be issued and sent out. Access to the 7th National Catholic School Improvement Colloquium will not be permitted if payment has not been received before Monday 5 October 2026.

## Registration amendments:

- Registrations are transferable (name change) if you are no longer able to attend.

- One name change per registration is free of charge. Further name changes will incur an administration fee (see below).

**Registration cancellation policy:**

- Cancellations must be advised in writing by the cancelling party to [cesa-nsic@conferencenational.com.au](mailto:cesa-nsic@conferencenational.com.au).
- A cancellation and admin fee will apply. See below for fees:

When you cancel	Admin fee	Cancellation fee
From registration launch to 29 August 2026	\$55	10% of total invoice amount
From 30 August – 26 September (6 weeks before event start)	\$55	25% of total invoice amount
From 27 September – 3 October (2 weeks before event start)	\$55	50% of total invoice amount
From 4 October (1 week before event start)	\$55	100% of total invoice amount

- For late cancellations:
  - In case of a medical emergency, a medical certificate must be provided within 72 hours of the medical emergency. Partial refunds will be considered at the discretion of the conference committee and are not guaranteed.
- No refund will be given for non-attendance.
- The credit card surcharge will not be refunded for cancelled registrations.
- Cancellation of social events (if applicable): Payments are non-refundable after 29 August 2026.
