



## SUBMISSION GUIDELINES

### Submitting Your Presentation Proposal

Presentation proposals will only be accepted via the online submission process (please do not email your submission).

Presenters will be required to provide the following information during submission:

1. Complete the Title of your presentation
2. Nominate Theme and Keywords
3. Choose from the Keyword list
4. Complete details of Authors and Affiliations
5. Complete the Presenting Author Biography
6. Complete a 250-word presentation proposal

### Themes

Your presentation proposals should align with one or more of the following themes:

- Advances in assessment, mediation, remediation, and long-term harm prevention.
- Advocacy and change
- Best practice in future research.
- Centring lived experience and professional engagement under the principle "Nothing About Us Without Us."
- Children's rights, developmental needs, and intersections with family law.
- Connections between PA, family and domestic violence, and shared parenting.
- Countering misinformation and misrepresentation.
- Evidence-based interventions and practical solutions.
- Harnessing the power of digital platforms and activism to drive change.
- Innovative and effective advocacy strategies.
- Public policy, human rights and the law
- Socioeconomic, cultural, and health impacts of Parental Alienation.
- Strengthening advocacy through first-hand accounts and survivor-informed practice.
- Targeted Families and Adult Alienated Children's forum.
- The child in court and mental health, assessment and remediation practice.



- The role of policy, legislation, and anti-PA frameworks in both local and global contexts.

Submissions will be reviewed, and the committee will nominate the best delivery format for your presentation based on the conference program.

- **Acceptance & Limits:** Acceptance decisions are final and determined by the Committee and its appointed reviewers. A maximum of two presentation proposals per author will be accepted.
- **Approvals:** Authors are responsible for obtaining any required permissions or approvals from relevant parties.
