#### State Medicaid Technical Assistance & Enterprise Monitoring

Deloitte facilitated visioning sessions to help state agency leaders identify which priority initiatives to include in its State and Local Fiscal Recovery Fund (ARPA SLFRF) requests. Federal funding was secured for 10 broad reaching initiatives, and the team helped define the strategy, business processes, technologies, and implementation plan over a three fiscal year period. Impacted areas such as, electronic health records, broadband, drinking water, and back office administrative systems saw improvement in the efficiency and optimization of service delivery.

#### **State Health Equity Proposal**

Deloitte developed a comprehensive health equity proposal that was included in a state's 1115 waiver renewal proposal. The project also developed a governance model and implementation plan to promote a health equity focus within all existing state programs and initiatives.

Additional emphasis was placed on competitive integrated employment and payment design for HCBS and I/DD.
