# **Examples of Our Work**



We support a variety of health-related initiatives in Tennessee, including with TennCare and the Departments of Health, Economic & Community Development, and Finance & Administration.

#### Patient-Centered Medical Home (PCMH) and Health Home Training & Technical Assistance

Supported more than 85 PCMH practices and 21 health home organizations that serve more than 600,000 members, resulting in a 3% reduction in the total cost of care and approximately \$23 million in performance payments for the practices.

#### **Rural Health Care Task Force**

Facilitated a task force comprised of 34 public and private stakeholders to develop a report containing \$197 million in recommendations to support access to care, social drivers of health, and workforce development.



We are supporting several Kentucky agencies, including Department for Medicaid Services, Department for Community-Based Services, and Department for Public Health.

### Children's Waiver Feasibility Study

Determined whether a 1915(c) waiver for children with autism spectrum disorder, intellectual disabilities, or related conditions, and/or severe emotional disability may be successful in Kentucky, leading to the legislature providing funding for a new program beginning in 2026.

# **Compliance Support for Ryan White Part B**

Developed policy guidelines to increase compliance with federal requirements, and developed monitoring tools to improve department capabilities to evaluate program components (e.g., programmatic, fiscal, administrative) of Ryan White Part B subrecipients.
