Risk Assessment

Consequence = direct result of a past action



Risk = Potential future bad outcome

Problem Solving

Joint responsibility – case manager, program coordinator, tenant, family, peer support, landlord (if applicable)

Use Harm Reduction framework

If the risk remains low and the tenant is willing to try, we don't stop trying new interventions until we've exhausted all options

If the risk remains low and the tenant is willing to try, we don't stop trying new interventions until we've exhausted all options.



Tips for Developing Interventions

Asking or telling the tenant to follow the rule in the future is *not* an intervention

 \mathbf{x} Don't do the same intervention repeatedly and expect different results.

? Don't assume you know the root of the problem.

Work within the tenant's point of view – not against it.

Admit to your team when you're biased or weary.

Putting It All Together

- Our primary goal is keeping people housed
- Complete a Risk Assessment before determining consequence or intervention
- Include the tenant in problem solving
- Don't give up until you've exhausted all options or risk is too high to continue
- When you think you've exhausted every possible intervention, get creative
