I am leading a team of Engineers. Technicians, electricians and works to achieve the goals as mentioned above.
- Mechanical workshop: I am doing maintenance of all municipal fleet and also attending breakdown of the same fleet.



• Facility maintenance: I am responsible also for maintenance of all municipal building and municipal facilities. I have to ensure that all municipal buildings and facilities are accessible, safe and well maintained.

The above are the current functions of the department that I am responsible for. I am reporting directly to the account officer (Municipal Manager)

Organization Overview: The department that I am heading for is responsible for supply, maintenance, operation and control of electricity distribution in the license area of electricity supply as per NERSA in Govan Mbeki Municipality. Currently, the municipality is purchasing its bulk electricity primarily from Eskom. The municipality is currently not generating any electricity for its consumers.

The department also looking after mechanical workshop and building/facility maintenance of all municipal fleet and fascilities.
