



### What is a Signing Official?

- Should be the **highest elected official**, or a designated proxy by the highest elected official, for the agency.
- Cannot be the Project Director, Financial Officer, or Alternate Contact.

### What is an Alternate Contact?

Individual not identified as Financial Officer, Project Director, or Signing Official who is involved in subgrant management and should receive grant communications.

## System for Award Management (SAM)

**Switching from DUNS to UEI**

Starting Monday, April 4, 2022, you can no longer see or use the DUNS Number anywhere in SAM.gov. The new Unique Entity ID will be the official governmentwide identifier used for federal awards.

- April 4, 2022 - SAM requires use of Unique Entity Identification (UEI) in place of DUNS Numbers

---

**Renewing SAM - FREE!!!!**

- An active SAM is required in order to receive Federal Funds and to be reimbursed by WI DOJ
- Your agency may receive an email from the Grant Support Specialist notifying you to renew SAM and to provide proof of renewal.
