



## PARTNERSHIP & EXHIBITION BOOKING FORM

Information about Data Protection when making a booking for the 2026 IEEE International Conference on Robotics & Automation (ICRA)

Below you will find a quick overview of what happens to your personal data when you are using this booking form.

## 1. DATA CONTROLLER:

On behalf of the IEEE Robotics and Automation Society, your data will be processed by IEEE International LLC, 445 Hoes Lane, Piscataway, N.J. 08854, USA, Email: <a href="mailto:privacy@ieee.org">privacy@ieee.org</a>, which acts as Data Controller as defined by the EU Regulation (EU) 2016/679 (General Data Protection Regulation, GDPR).

## 2. DATA PROCESSOR:

The Data Controller has contracted AIM Austria GmbH with the role of handling the partnership bookings for the 2026 IEEE International Conference on Robotics & Automation (ICRA). AIM Austria GmbH acts as Data Processor on behalf of IEEE International LLC and according to the general Privacy Policy as published on the website <a href="https://privacy.ieee.org/policies">https://privacy.ieee.org/policies</a>.

## 3. LEGAL BASIS:

You provide your personal data for booking purposes on the basis of your freely given and informed consent (legal basis). By making a booking for the ICRA 2026, you agree that AIM Austria GmbH on behalf of IEEE International LLC and IEEE Robotics and Automation Society is allowed to use all booking data given for a computerised handling of the conference.

# 4. PURPOSE FOR DATA COLLECTION AND PROCESSING:

The partnership/exhibition booking is not possible without processing personal data. All information and personal data requested in the booking form is collected, processed and used for the only purposes of organizing the ICRA 2026, facilitating bookings, mailings from IEEE International LLC to announce activities of potential interest to you, statistics after the meeting (fields of interest, country), and for ensuring a smooth operational process. The processing will be conducted in compliance with the applicable European data protection legislation, namely the Regulation (EU) 2016/679 (General Data Protection Regulation, GDPR).



### 5. WHAT TYPE OF DATA ARE COLLECTED / PROCESSED:

When making a booking you consent to provide personal data (name, surname, email address, etc.) to the Data Controller and Data Processor listed above. In the context of this event, photographs and/or films may be taken by or on behalf of the organizers. By making a booking for the event, you consent that photographs and video materials in which you are depicted may be used for press coverage and published in various (social) media, publications and on websites of the conference and organizers.

#### 6. STORAGE PLACE AND TIME:

Except for legal obligations, the personal data will be stored only for the event's duration (including the postprocessing) in secure servers belonging to the Data Processor. Notwithstanding, AIM Austria GmbH may conserve some personal data also after the termination of processing, exclusively for the scope of defending or safeguarding its rights, or in those cased as defined by law or by order of a judicial or government authority.

## 7. DATA SHARING:

Personal information may be transferred and shared with Data Processor only. The Data Controller will take appropriate steps to ensure that the recipient of personal information puts in place an adequate level of protection for such personal information in accordance with applicable legal requirements.

### 8. YOUR RIGHTS:

You can revoke your consent at any time. Please be aware that the withdrawal will not allow you to make a booking for the ICRA 2026. Moreover, as provided by the GDPR, you have the following rights with respect to the personal data concerning you: Right to information, correction, deletion, limitation of processing, objection of processing and the right of data portability.
